On another note Region 7 set the quota for the 2 new split antelope districts at 300 less than the old quota for the entire Region. 7,500 2023 entire region compared to 7,200 2024 (3,000 + 4,200).



Dear Commission Cebull:

I am writing to express my viewpoint on removing the Yellowstone River hunting closure.

My first comment is that FWP needs to do a better job of informing the stakeholders about this proposal. I, like many others, found out about it only because of an Outdoor Life article. I have contacted many others, including dozens of

landowners, but no one knew of this proposal. In 2013, Steven Atwood (now an FWP biologist in Region 7) completed a Master of Science evaluating landowner attitudes on lifting the closure. Quoting Atwood- "Engaging Inside landowners and other key stakeholders, such as sportsmen, in the decision-making process regarding the direction of the Yellowstone River Closure policy will be essential in minimizing conflict." Unfortunately, FWP has not followed this recommendation. Atwood also found that 77% of landowners within the closure area did not favor its removal. It is misleading that the supporting documentation provided to the commission and the public by FWP on this issue reports viewpoints of both landowners outside of the closure area and within, indicating that most landowners supported the removal of the closure. The Thesis can be viewed https://example.com/hereal/library.ndsu.edu] and contains valuable insights for the commission on this decision.

In addition, I do not think that the hunter survey information is representative of hunters' views on this issue. It would have been easy for the FWP to survey waterfowl hunters within the counties adjacent to the closure, and that would have been much more representative of the public that will be affected by this change.

Another noteworthy piece of history in this discussion was when FWP removed the closure in 1975 and lost a lawsuit in the 16th Judicial District in Forsyth, Montana. "The district court judge concluded that the Fish and Game Commission did not go through an adequate public process and was negligent in notifying the public of the proposed abandonment." Why are they repeating those mistakes? I reviewed all of the news releases and public notices on the FWP site, and this proposal was not posted.

The use of closures as a waterfowl management tool to retain waterfowl in an area and provide better hunting is widespread and effective across Montana and the country. Nearly all State and Federal Wildlife refuges have closed portions, and areas like the Missouri River in Cascade County and Nelson Reservoir in Region 6 are examples of such closures. According to the US Fish and Wildlife Service Waterfowl Handbook, "Food availability, habitat diversity, and sanctuary are keys to retaining waterfowl in an area during winter". Not only do these closed areas provide hunters with better opportunities, but they also serve a vital biological purpose by providing secure roosting areas, thereby retaining more birds in an area. For FWP biologists to suggest that removing this closure will not change hunter success is not based on data. There are hundreds of miles of river open to boat hunting on the Yellowstone and Big Horn, but only one section is closed. In addition, for FWP to infer that only hunters with access to private lands can hunt in the Yellowstone Valley is just not factual. There are numerous parcels of school trust land and hundreds of Block Management properties throughout the closure area. These areas provide thousands of hunter days yearly, and jeopardizing field hunting for a handful of river hunters who think there is inadequate opportunity is somewhat ridiculous.

I have hunted around Hysham, MT, for over 20 years. I understand the R7 wildlife manager's assessment that removing the closure would increase hunting opportunities. However, I firmly believe that this change will reduce the quality of the opportunities for much of the population that hunts in this area by pushing geese either out of the area or into areas where they are not accessible to the majority of the hunting public.

I will use one area to illustrate my point. Just upstream of Hysham, near Myers Bridge, is the Isack Homestead WMA (1,168 acres) and Howrey Island (592 acres). Presently, thousands of geese roost in this section of the river. The WMA is all accessible by road, and there is a boat ramp at the bridge. If the closure is removed, jump shooters and boats will likely blow the geese out of this section of the river quickly because of how accessible it is. Presently, many block management properties adjacent to the WMA provide hundreds of hunters access to good opportunities to harvest geese in the fields. Under this scenario, you will also push the geese into a smaller roosting area (increasing crowding and possible Avian flu outbreaks) and make many of them inaccessible to most public hunters who can't afford to lease ground or pay a guide. The second possibility is that, given the lack of safe roost spots or crowding, the geese will leave the area entirely.

I think it is essential that the commission also consider the economic impact of this change on the rural economy around this area, which is already suppressed by the downturn in sugar beet prices. If overall hunter success is reduced, it will undoubtedly reduce the number of hunters coming to the area and spending money there. Over the last twenty years,

the hunting environment has changed dramatically, and the BMAs provide most of the hunting opportunities for hunters new to the area.

Thank you for reviewing my comment on this proposed change. It is hard for me to believe this change is being proposed because it will not benefit ordinary hunters or the local economy; however, it will likely benefit a few boat hunters and the small group of leases and guides with secure roosting areas under their control.

MT Fish and Wildlife Commission,

A 140 km stretch of the Yellowstone River, traversing Treasure and Rosebud counties from Hathaway to the confluence with the Bighorn River, was closed to waterfowl hunting in 1959 by the state of Montana. This was done to provide sanctuary for a then-struggling Canada goose population. Waterfowl

hunting was, and still is, prohibited on the river, islands and adjacent backwaters.

There is a current proposal to abolish this waterfowl hunting closure. I am bewildered that such a short-sighted proposal would gain any traction. Why would MT FWP ever want to destroy this world-class goose hunting opportunity they have so successfully fostered over the last 60 years?

A few reasons not to change the current system include:

1) If it ain't broke don't fix it!
The Yellowstone River
waterfowl closure currently
provides some of the best

field hunting for Canada geese in the lower 48 states with ample opportunity for public participation via state owned property, block management and other means of private land access. The proposed dissolution of such a successful experiment is counterintuitive.

2) Opening the river to waterfowl hunting, like that already available on the rest of the Yellowstone River and entire Bighorn River, will surely diminish the overall goose harvest in the area at a time when the North American Canada goose population is at

- an all-time high and in need of higher harvest rates.
- 3) Disturbing the currently protected roosting sites on the river will force the geese further south into Wyoming and Colorado, significantly reducing hunting and harvest opportunity for MT residents.
- 4) The duck population on this stretch of the river is very low compared to the Bighorn and upper Yellowstone Rivers, presumably due to habitat differences and lack of preferred feed. Jeopardizing the proven goose hunting potential to allow for some unproductive duck hunting

would be an unbelievably poor trade-off!
