### UGBEP Biennial Budget – Starting Balance (Jul 1, 2023)

HB5 = Capital Fund (Habitat enhancement, bird planting)

- \$2.5M Authority for FYs 2024 and 2025 (ends June 30, 2025)
  - License...... \$1,520,000
  - Bird Planting.. \$388,000
  - PR \$...... \$600,000 (Now UGBEP)
  - TOTAL.....\$2,508,000



# UGBEP Biennial Budget – March 2024 Recap

• HB5 = Capital Funds (Habitat enhancement, bird planting)

- As of February 27, 2024
  - Unallocated Balance: \$2,006,277





## **VPA-HIP Budget**

- Total grant award in 2020: \$1,894,060
  - \$1,595,804 Habitat
  - \$298,256 Overhead
- 3-year grant awarded late 2020
- 1-year extension, expires March 31, 2024

FY24 Available Balance: \$451,500

FY24 Expenditures: **\$478,262** 



UGBEP Proposals –Jan '24

NEW - Rate and Enrollment Cap Increases starting April 1.

- CRP Leases
  - \$5 to \$10 per acre
  - 320-acre cap increased to 640 acres
- HML
  - Payment increase ~\$5 more for security and thermal cover
  - Acreage cap increased 160 to 320 acres.
- Wildlife-friendly practices ~ \$5 increase per acre.






# 2024 Field Season: New UGBEP Habitat Projects by County (n = 16)

# Voluntary Public Access-Habitat Incentive Program (VPA-HIP) Grant

- Farm Bill program to expand public access
- Funds UGBEP's Open Fields for Game Bird Hunters "Open Fields" and eligible HMLs
- \$5/CRP acre per year enrolled
- Walk-in game bird hunting, no further permission

### Open Fields 2023 Enrollment Stats

- 38 new enrollments
- 9,377 Habitat Acres (OF & HML)
- 11,881 Walk-in Access Acres (~2,500 acres donated)



# 2024 CRP Mailing

- FSA/FWP MOU CRP data-sharing
- Statewide mailing (1,308) to generate interest for a CRP lease agreement on private & public lands during CRP sign-up (3/4 – 3/29)
- UGBEP "deadline" to apply April 19



# **UGBEP & Partners Update**

### Region 5 – PF / BLM / FWP

- Will be phased out end of 2025
- BLM funding challenges
- WMA project sites phased to permanent cover
- Goal for WMAs crop-share agreements to continue habitat management.

## UGBEP & Partners Update, cont'd

### Region 2 – NWTF / USFS / FWP

- Cooperative position is vacant.
- Partnership will seek to fill vacancy to continue efforts in R2 with some expansion into R1 and R3.



### UGBEP & Partners Update, cont'd

### PF Farm Bill Biologists Support

- Historical UGBEP contributed modest funds to support 4 positions in Conrad, Chinook, Scobey, and Billings
- Currently Mig. Bird Wetland Program & UGBEP contribute to the PF State Team (UGBEP \$10,000/year for 3 years)



### 2024 UGBEP Pheasant Releases

- 2 Contracts: Beaverhead and Phillips counties
- 165 Pheasants total (Pre-auth)
- UGBEP contributing \$11 cost-share and pay loaded mileage \$1.34.
- Poindexter Slough FAS (370 acres) and private land (1,610 acres).
- Estimate \$1,815 pheasants and \$400 mileage = \$2,215 total costs.
