 These columns reflect the opportunities that were drawn as well as the overall quota for each opportunity.


 These columns reflect the total number of licenses drawn for each opportunity, as well as any surplus (leftover) licenses that were not drawn.


LANDOWNER: Landowner opportunities are drawn first and could be up to 15% of the overall quota depending on the number of applications. However, due to the nonresident 10% cap, nonresidents landowners may only receive a maximum of 10% of the overall quota.

 **Resident Landowner:** From left to right: Resident landowner quota (15% of overall), number of applications, number of successful applications.


 **Nonresident Landowner:** From left to right: Nonresident landowner quota (10% of overall), number of applications, number of successful applications.

REGULAR DRAWING:

 **Resident (regular):** From left to right: Resident (regular) quota (same as overall), number of first choice applications, number of second choice applications, number of third choice applications, number of successful first choice applications, number of successful second choice applications, number of successful third choice applications.

 **Nonresident (regular):** From left to right: Nonresident (regular) quota (10% of overall), number of first choice applications, number of second choice applications, number of third choice applications, number of successful first choice applications, number of successful second choice applications, number of successful third choice applications.

Note: Although the nonresident quotas are set at 10%, that entire quota may not be drawn by nonresidents. The random drawing determines how many residents/nonresidents are selected within the quota amount, but the 10% is the maximum amount for nonresidents.

 All nonresidents, regardless of landowner status, are capped at 10% of the overall quotas. This is why the Nonresident Landowner and Nonresident (Regular) quotas are the same. These quotas are not separate (10% for landowner AND 10% for regular nonresidents), the 10% applies to nonresidents overall.
