

Boundary Change Master List December 05, 2019

Specific proposed changes for 2020-21 are listed below. All other season components except calendar year rotation are proposed unchanged from 2019.

DEER, ELK, MOUNTAIN LION, HD BOUNDARY CHANGES

HDs 130, 132, 140 & 170: Remove HD 132 by placing private lands from HD 132 into an expanded HD 170, and the public Forest Service lands from HD 132 into expanded HDs 130 & 140.

HDs 150 & 151: Remove current deer/elk/lion HD 151 by combining it with HD 150.

HDs 211 & 214: Change deer/elk/lion HDs 211 & 214 by using the road feature of the Storm Lake road and trail to separate the HDs and removing the East Fork of Rock Creek Road boundary.

HDs 212 & 213: Change deer/elk/lion HDs 212 & 213 by using the Flint Creek Mountain watershed to separate the HDs and by removing the Racetrack Creek boundary.

HDs 213 & 217: Change HDs 213 & 217 by using section lines of 21 and 16 (T9N R10W) to separate districts.

HDs 404, 421 & 444: Change deer/elk/lion HDs 404, 421 & 444 by modifying the shared boundary of these districts.

HDs 411 & 412: Change deer/elk/lion HDs 411 & 412 by making part of the western portion of current HD 411 part of HD 412.

HDs 449 & 452: Eliminate current HD 449 by combining the two HDs into a single HD452.

HDs 500, 502, 530, 570, 575 & 590: Combine all R5 mountain lion HDs into a single management unit with one quota.

HDs 611 & 670: Remove the current deer/elk/lion HD 611 boundary by combining it to HD 670. An antelope change is also proposed to make deer/elk/antelope HD 670 the same.

HD 620: Change HD 620 boundary to make HWY 2 the northern edge of the boundary. Change also applies to antelope HD 620.

HDs 640, 641, 651 & 670: Change current deer/elk/lion HDs 640, 641, 651 & 670 through consolidating HD's 640, 641 and parts of HDs 670 and 651 into one hunting district (640). This will overlap with the proposed antelope HD 640.

HD 641: Remove HD boundary 641.

HDs 650 & 651: Combine HDs 650 & 651 into HD 650 and remove HD 651 boundary. An antelope change is also proposed to make deer/elk/antelope HD 650 similar.

HDs 680 & 690: Combine HDs 680 & 690 into one district (690) and remove current HD 680.

ANTELOPE HD BOUNDARY CHANGES

HD 329: Reestablish antelope HD 329 following the 2006 legal descriptions, with editorial amendments.

Specific proposed changes for 2020-21 are listed below. All other season components except calendar year rotation are proposed unchanged from 2019.

HDs 470 & 471: Combine HDs 470 & 471 into one district (471) and remove current HD 470.

HD 491: Adjust antelope HD 491 so that the entire HD lies within the Region 4 boundary.

HD 514: Expand antelope HD 514 to increase hunter opportunity by modifying the eastern edge of the boundary.

HD 590: Adjust antelope HD 590 so that the entire HD lies within the Region 5 boundary.

HD 600: Change HD 600 boundary by making HWY 241 the new eastern edge of the boundary.

HD 620: Change HD 620 by making HWY 2 the new northern edge of the boundary. Change also applies to deer/elk/lion HD 620.

HD 640: Create a new antelope hunting district 640 to overlap with current deer/elk/lion HD 640. Proposed HD 640 would encompass the eastern portion of the current 670 antelope district beginning at State Route 24 and the eastern portion of the current 650 antelope district north of the Missouri River.

HD 650: Modify the northeast boundary of HD 650 to follow the Missouri River instead of Highway 2.

HD 670: Shift the western boundary of HD 670 to the Harlem-Turner Road (Route 241). Change also aligns with the proposed change for deer/elk/lion HD 670.

BEAR HD BOUNDARY CHANGES

BMU 319: Expand BMU 319 by incorporating deer/elk/lion HDs 390, 391 & 392.

BMUs 411, 420, 440 & 450: Consolidate all BMUs into a single unit (BMU 400).

BMUs 411, 420 & 580: Enlarge BMU 580 by moving the northern boundary north to the R5 boundary and reduce BMUs 411 & 420.

MOOSE HD BOUNDARY CHANGES

HDs 306, 307 & 310: Remove HDs 306 & 307 by combining to HD 310 and modify 310 which will be similar to deer/elk HD 310.

HDs 304 & 311: Combine HDs into one boundary (311) and remove current HD 304 with the total quota of antlered bull licenses remaining at 5.

HDs 361 & 362: Combine HDs into one boundary (361) and modify the boundary to match current deer/elk HD 361.

HD 447: Create new moose hunting district 447 which would encompass all of current deer/elk HD 447.

BIGHORN SHEEP HD BOUNDARY CHANGES

Specific proposed changes for 2020-21 are listed below. All other season components except calendar year rotation are proposed unchanged from 2019.

HD 482: Modify bighorn sheep HD 482 by establishing the northern boundary as the Missouri River instead of the north bank of the Missouri River.

HD 622: Extend the eastern boundary of HD 622 to run along the current border for the Deer/Elk HD 631

MOUNTAIN GOAT HD BOUNDARY CHANGES

HDs 327 & 328: Combine HDs 327 & 328 into one district (327) and remove current HD 328.

HD 521: Create a new mountain goat hunting district 521 which would encompass portions of Stillwater and Sweet Grass counties.

BISON HD BOUNDARY CHANGES

No changes
