Thank you commissioners for the opportunity for public input on a resource that is near and dear to my heart. I am a life-long waterfowl hunter and have hunted all over the country, but my home state of Montana is still my favorite place to hunt. As our climate continues to change, waterfowl migrations are adapting to the changes. These changes have been very noticeable, especially during the 23/24 season. In January I polled the Montana Waterfowler Facebook group (which represents a large portion of Montana's waterfowlers) about our current season framework. The nature of the poll was to see if there was any interest in changes to our current season frameworks, specifically the Pacific Flyway, where I reside. There were 297 respondents to the poll and 225 of them (77%) were in favor of having a continuous season using the last date available set by the feds for ducks and geese. (e.g. January 31 and the previous 106 days) as our season going forward.

There was also interest in the creation of a north and south zone within the pacific flyway, with the north zone being defined as an area east of the rocky mountain front and north of the Missouri river, which is very logical because that area doesn't have the open water opportunities later into the season like the southern zone has. It is also suggested that the north zone uses the current season framework.

If these changes were enacted it would offer more hunting opportunities for all waterfowlers in the state, it would also help support local communities through hunters traveling to hunt in areas where the season is open when their local season might be closed.

Central flyway respondents seemed happy with the current set-up, but the majority would like to see the Yellowstone closure remain in effect, as having a safe roost for the birds is critical to keeping the birds in the area.

Thank you for taking these amendments to the current proposals into consideration.

First I recognize I as a Wisconsin resident, you may find my input less valuable, however as an engaged and passionate waterfowl hunter from Wisconsin who has traveled to and hunted around the Yellowstone River restriction area, I have insight with merit. My waterfowl experiences include throughout Wisconsin for both ducks and geese of all species, as well yearly travels to continental waterfowl destinations including Minnesota, Michigan, North Dakota, Montana as well Canadian travel to Manitoba and Saskatchewan provinces.

As a waterfowl hunter with 22 years of experience (age 45), I continue to see both growth and reduction in population densities and resulting population impacts based on policies that are enacted. With an observed understanding with personal recorded data to support, I see the value of having areas that provide relief for migrating species while they are at their most vulnerable from a health perspective, during their migrations. The continued restriction on the Yellowstone River between the confluence of the Bighorn and Yellowstone rivers to the Rosebud-Custer county line makes an immediate impact on the populations of migrating species who find refuge on it. At the same time, allowing such a refuge provides significant improvements in the quality of hunter opportunity around this refuge if they are not pressured both on land and on water. Providing hunter opportunity is important, however I would promote quality over quantity 10 out of 10 times. The economic value to maintain quality hunting opportunity in my opinion would outweigh more access opening the restricted area. Waterfowl are temperamental, you can pressure them where they feed, and the result is they will make a small relocation to find safe nourishment. If you pressure them both where they feed and where they roost (on water), they will leave making a larger change in location, aka, leave the Yellowstone River. This would result in less quality opportunities for all.

I hunt geese frequently on fields in the area along the closed section of the Yellowstone River and can honestly say that I am very against this section of river being open to waterfowl hunting. As with many other reaches in Montana, heavy hunting pressure on the roost has been proven to push birds out of the area and would reduce hunting opportunities and income to the local communities by a significant amount. I travel to the Forsyth area 2-3 times a year to hunt waterfowl and spend close \$200-\$300 per day per person in the local communities. If hunting is allowed on the Yellowstone River and the birds move on because hunting pressure is too great on the roost it will have a large negative impact to these local communities. There are plenty of hunting opportunities for waterfowl without pressuring the birds on the water. If hunters are specifically interested in targeting waterfowl on the water there are many other high quality areas to hunt them nearby, specifically the Bighorn River and upstream/downstream areas on the Yellowstone. I am writing to comment on the Department's recommendation to lift the hunting restrictions on waterfowl hunting between the confluence of the Yellowstone and Bighorn Rivers to the Rosebud/Custer county line. This is a terrible idea.

I grew up in Billings and have been hunting ducks and geese down there since I turned 12. There is no other place in MT that offers this type of field hunting for ducks and geese in MT. All of us who hunt in MT understand that quality hunting is gettting harder and harder to find for the average Montanan. This change will benefit those with jet boats. It will directly disadvantage those hunters who load their decoys up in the back of the truck, get up early and set up their spread, and then wait for one of Montana's great wildlife spectacles to begin.

All of us know that elk stay on private refuges where they are safe. But, unlike the elk refuges, these geese must leave to the fields for food every day. When they are done feeding, they move back to the river for the night where they can rest.

On those days, when the geese are in, the sky is literally filled with geese landing in fields from Custer to Rosebud. On most mornings, you can hear hunters getting to experience these huge flights of geese on either side of the river. Because these geese fly all day, hunters have incredible opportunity to harvest Canada geese.

Contrast that with our land on the upper Yellowstone just west of Reedpoint. There, hunters ambush the geese on the river, and the day's flight can be over in the first 15 minutes of the day. It is a completely different hunting experience, and it certainly does not fill the hotels of Hysham and Forsyth each weekend in December and January.

When I was on the Commission, this change was pushed by a few jet boat owners in Billings. I own several jet boats. However, most people do not. In my experience, there are a lot of good opportunities to hunt geese in the fields for the average Montana sportsmen. Opening this stretch of river will destroy the quality of that opportunity.

It is true that several good block management properties have been leased up by outfitters for Deer Hunting. However, in my experience, there are very few goose outfitters, and, as soon as the deer season ends, the farmers are thrilled to have you come harvest some geese before they hit the first winter wheat sprouts.

If you have not experienced this stretch of the Yellowstone when the geese are in, I would urge you to take that opportunity. It is really unique. And, this proposeds change will irrevocably change this waterfowl convergence on the lower river, and it will destroy the best field hunting opportunity for the resident waterfowl hunters in Montana. It is not broken. In fact, it is one of the great success stories of Montana hunting that still resembles the Montana we grew up in. Please do not turn it into another stretch of river where the birds are hounded all day by guys with boats ripping up and down the river. We all know what happens when birds are hounded and have no safe place to rest. They fly somewhere else where they are protected, and that will be a good ways south of the Yellowstone where Montana hunters will not have the same opportunities they do today. Please don't do this. It is a huge mistake.

CF zone 2 Canada goose season should open later in October and go through January 31st with no 12 day split. The first couple weeks that begin late September and early October usually have minimal Canada goose migration and most hunters would agree going a little later in January would be ideal for zone 2 Canada goose hunting when a good amount of birds have arrived in the area.

Electronic callers should be allowed for the Montana CF spring snow goose season. If you're going to have this season you should open up all of the tools needed to bag the few birds that migrate through the central flyway. What little opportunity there is having electronic calls would aid in hunters pursuit of light geese in the CF in spring.

How much legal and bureaucratic hoops do we have to jump through to research to have a spring season for light geese in Montana's portion of the pacific flyway? It makes no logical sense why Alberta hunts the exact same Western Arctic breeding light geese that migrate through Montanas PF. Why are we not using their science!? The federal framework should be amended to allow light goose hunting beyond the March 10th cutoff. I am just one person but the logic for the closure on March 10th seems arbitrary at this point and knowing that hunters only account for about 2% of snow goose mortality on this continent, having a season for light grease in the PF should be an opportunity given to Montana constitutes.

As a hunter who supports access to public lands in Montana, I can see how FWP might see opening the Yellowstone River refuge up to hunting as a win for public lands. Yet, there are many negative aspects to this happening and not many good ones. First, this refuge has been a huge conservation success story with the goose numbers doing well in this area and hunters having success, why would you want to end something that is working well? Second, in terms of access around the Yellowstone River, there are plenty of BMA areas that we have access to which having the river as a refuge increases the quality of those hunting opportunities. Third, most of the birds in this valley roost (sleep) on the river and feed in the fields. Hunting birds where they roost will cause birds to leave the area entirely instead of hunting birds in the fields where they will go back to the river and find different fields to feed in, effectively allowing both hunters to be able to hunt, and the birds being able to go back to somewhere safe. Fourth, opening the river to hunting will encourage hunters to take boats out onto the Yellowstone in dangerous conditions late into the season with ice flows and strong currents into ice dams. This would put a strain on the local EMS services and potentially put more lives at risk. Lastly, the long term effect of disbanding a refuge will ultimately result in a decrease in hunter success which will decrease hunter attraction to the area which will negatively impact the local economies that rely on hunters to frequent their businesses in the winter months. I hope that this input, along with many other public land hunters who share my same feeling, will influence FWP to change their mind and not open the Yellowstone River refuge.

The FWP proposed opening of the 87 mile stretch of the Yellowstone River between the Bighorn River and Hathaway for water fowl hunting is a proposal we adamantly oppose for a number of reasons.

First, since 1958 this closure has supported a haven for waterfowl. The waterfowl are field hunted extremely hard in this area and the river is their only sanctuary to find a resting spot free from sunup to sundown field hunting. Not only will opening the river deprive the waterfowl of rest but it will disturb the bald eagles habitat as well.

Second, because this stretch of the Yellowstone has been closed to waterfowl hunting since 1958 it has created some of the best field hunting of Canada Geese in the country. Business's in the area thrive because of the hunting opportunities. Opening the river for hunting will destroy the resting area for the geese disrupting the balance that has created the great hunting and harm these areas economically.

Third, the Yellowstone River is generally unnavigable in December and January. This invites conflicts between hunters and landowners from trespassing. As a avid waterfowl hunter I feel it is a bad idea to open the yellowstone river safe zone to hunting. I mainly hunt geese from billings east to miles city. Over the years I have seen time and time again that the goose hunting is better from the mouth of the big horn river east. I strongly feel that this is the case due to the fact the these birds feel safer in that stretch east. When we hunt from billings to the mouth of the big horn the increased hunting pressure on the river decreases our hunting abilities in fields. Once the boat traffic starts up the birds are scared off the river and usually don't return until dark that day giving hunters a one shot opportunity to limit out for the day. When we hunt from the mouth of the big horn river east we notice much less boating activity subsequently giving us more opportunities to limit out on these days. We watch birds come off the river in the morning return to the river late morning come back off the river early afternoon and return to the river just before dark. During these times field hunting is very successful over just having one shot in the morning when all the birds are cleared off the river in one push. In my opinion opening that stretch of river will ruin waterfowl hunting in Eastern montana due to the fact that these birds loose resting zone or safe zone. It has been to my understanding that over the years the goose numbers have increased considerably and are compromising there nesting and summer habitat to the north. Why would montana fwp even consider doing something to reduce hunting opportunities that in the end will only hurt a species that numbers are exploding throughout this hunting zone. An advisors group of seasoned waterfowl hunters needs to be established to inform the commission of beneficial changes to the seasons. Using phone surveys of random holders of waterfowl licenses does not give the commission accurate data to make changes to seasons etc. but takes the opinions of hunters that only hunt a small amount of the season and do not have the knowledge base of hunting the entire season. It should also be noted that hunters that only hunt small bodies of water until that water freezes do not represent a larger percentage of hunters that utilize both water and field locations and are much more knowledgeable of bird movements and biological responses that both local populations and true migratory populations exhibit when faced with weather and hunting pressure.

Waterfowl seasons need to start at least 3 weeks later in the Pacific Flyway. Conditions in Western Montana during the late September opening are usually not conducive to harvest due to only residential birds being available. By opening it this early, local birds are pushed to a limited amount of safe roost locations and completely eliminate their movements to limited public water bodies. In the areas where I have hunted over the last 30 plus years, opportunities on public land are nonexistent after the opening day and birds do not return to these areas until forced by weather and changing seasonal conditions later in the season. Also, pressure on these limited bodies of water conditions these populations to become nocturnal and then are completely unhuntable.

Also, the late season break that was eliminated should be reinstated, and there actually should be others as well to allow the birds breaks from hunting pressure. These breaks get the birds to return to bodies of water where pressure pushes them off of, and breaks nocturnal feeding patterns, thus allowing for more hunting opportunities when the season opens after the break.

A better start date would be the second or third Saturday in October with the youth season opening the previous weekend. This would coincide with pheasant season opening. It would also provide the season to be open when the first pushes of actual migratory populations of snow geese and swans. A good time for a 5 day closure would be the week before Thanksgiving. The second split would be Mon through Friday the second week of January.

By setting this schedule, opportunities would be created during peak migration periods and allow for the season to be extended to the end of January while staying within the USFWS 108 day guidelines. Also look to end the season on a Sunday instead of mid week. This allows youths to hunt the last weekend of the season without interference with their school attendance.

Chair Robinson, Vice Chair Tabor, Commissioners:

On behalf of the Montana Chapter of Backcountry Hunters & Anglers, we submit the following comments on the proposed 2024-2025 Migratory Bird Regulations.

Our members and supporters value our fair-chase hunting heritage and the wild public lands and waters habitat needed to support it.

Regarding the proposal to lift a ban on waterfowl hunting on an 87-mile stretch of the lower Yellowstone River, from the mouth of the Bighorn River to the Custer/Rosebud County line, Montana BHA understands and sympathizes with both sides of this issue.

In July, at the very beginning of this process, we had heard nothing but support for the proposal and we added this to our scoping comments: "we support expanding waterfowl opportunities within the framework of the existing federally controlled seasons in whatever areas of Montana that the shared public resource can sustain. The area between the confluence of the Bighorn and Yellowstone Rivers to the Rosebud-Custer County seems like it now fits that description. Let's open it."

Recently, however, as the idea has gained more attention, we're now hearing that the ban on hunting this section of river provides sanctuary for the birds, and once hunters start shooting at them the fear is that they might not remain in the area. When hunting in the area is good, we certainly understand why sportsmen and women wouldn't want to see things change.

We are empathetic to this position, and ask that the Commission carefully consider these concerns and continue to discuss with local biologists.

On the other hand, we also ask that the Commission weigh the opportunity for the public to hunt our public water.

We've heard from many public hunters who would love to hunt our public wildlife on our public water, and they argue there's no biological reason why they shouldn't be able to do that.

Relatedly, there's a lot more at play in terms of duck and geese numbers when you consider improvements to water quality, wildlife management, and habitat since 1958 when this closure was implemented. For example, the Clean Water Act was passed in 1972, Clean Air Act in 1970 and Land and Water Conservation Fund in 1964. A nationwide ban on non-toxic shot for waterfowl was passed in 1991. And there have been great changes to land-use in the area now as well, with no shortage of ag lands for birds to feast on.

Additionally, as you know, FWP surveyed hunters on this and of the 123 who responded, 79 percent said it would be acceptable or very acceptable to reopen this stretch of water to waterfowl hunting; comparatively, only 9 percent found this proposal to be unacceptable or very unacceptable (the remaining 12 percent were neutral). So there's clearly a hunter contingent who wants to see this opened back up as well.

Montana BHA sympathizes with the access and opportunity arguments from both sides of this issue, and our board lacks agreement on the best action. For that reason, we are not advocating for the hunting closure or the reopening, but do want to stress the importance of gathering good biological and social data, specifically through mandatory reporting and careful monitoring, should this stretch of river be reopened.

Thank you for the opportunity to comment, and for your careful consideration.

Sweet Grass Wildlife Working Group is a collaborative group of landowners, sportsman and outfitters that was formed in 2020. We submit the changes for the 2024 -2025 Waterfowl seasons for zone 2 of the central flyway.

Facts: Zone 2 is in the high plains mallard management area giving

the whole central flyway which allows 97 days of authorized duck season by USFWS. At current season dates we use 97 days for ducks including youth and falconry seasons. Zone 2 is currently using the 107 days authorized by USFWS for dark geese.

Due to the past few waterfowl seasons in zone 2 we have seen later migrations and combined with season dates we have experienced lower hunter opportunity. We have also experienced an increase in waterfowl hunters in Montana residents and an influx of nonresident waterfowl hunters "chasing migration" causing overcrowding when peak numbers are in area. It is a matter of fact and stated "waterfowl population numbers can't be affected by legal hunting and legal limits". Over the past several seasons we have

seen weather patterns change making seasons later and that has affected the waterfowl migrations in the southern portions of Montana affecting zone 2 waterfowl hunters using the outside dates USFWS allows gives hunters better opportunity to harvest waterfowl and hunting opportunity in the future. By moving seasons back and the potential closure of the YRC it also provides economic benefits for the town of Hardin and those towns in the 87 mile stretch of the YRC when tourism is very low besides giving more access and opportunity to waterfowl hunters. Proposals and support:

We support the elimination of Yellowstone River waterfowl closure that was originated for the purpose of Canada goose resting place due to low population numbers in the 1959. In modern times we now have an explosion of Canadian goose population (350,000 using the YRC) numbers which brings into question of justification exclusion area, also will alleviate hunting pressure in zone 2 and open more public access and opportunity.

Gentlemen,

I am writing to express my objection to the proposal to lift the current closure to waterfowl hunting on the Yellowstone in Region 7. This closure has been working well to hold geese in the area for 50 years or more. This has provided hunting opportunities in the Treasure/Rosebud area that far surpasses any of the other areas along the other 600 miles of river. I believe that opening the river will result in geese leaving the area earlier in the season as well as those birds that remain leaving the river to feeding areas in fields before sunrise and returning late, reducing decoying opportunities mornings and evenings.

As an owner of over a mile of riverfront in this area I am also concerned about increased trespass on our property by hunters accessing by boat. Also, we own well over 1000 agricultural acres in this area that are used by geese. We annually receive many offers to lease land for goose hunting. We do not take advantage of this increased income for various reasons, but many area landowners do.

FWP staff that I have spoken to in Helena have been unable to offer a reason why this proposal has come forward other than a vague "well It's come up off and on over the years". I am concerned about the lack of outreach to both the hunting public and landowners about this issue. FWP staff believes there was significant outreach because the "migratory bird biennial season setting dates" was a topic that was available for public comment. This is normally a very low public interest issue and there was no highlighting of this issue. FWP did send a one-question survey to 1000 waterfowl hunters that asked if they would be for or against lifting the closure. I was informed that the response to this survey was pro-lifting of the closure. I suspect that pretty much any question sent to hunters in MT that begins with a proposal to "lift existing hunting restrictions" would get a positive response from the majority of responders, especially those that are not familiar with the issue.

I am a landowner on the subject stretch of the river, a waterfowl hunter, the Vice Chairman of the Yellowstone River Conservation Council, a member of the Lower Yellowstone River Development Advisory Council and the first I heard of this proposal was this week via a grandson who lives in Idaho. I don't believe you have received adequate input from affected public to make an informed decision on this issue.

Generally, we don't see a massive difference in the number of birds that roost on the river west of Bighorn (out of the closure), compared to within the closure. One important thing to consider is the significant amount of river miles between public access points. Specifically, between Amelia and Rosebud West (36 river miles). Waterfowl hunters rarely go more than 5 miles from the nearest ramp, generally because half the travel is in the dark, before or after shooting light. It's hard to imagine hunting pressure along this stretch having a negative impact on bird habits and overall numbers, when large chunks of the current closure will rarely be accessed by hunters. The closure should be opened, and FWP should work to provide hunters and anglers more public access along that stretch of the river.

Thank you for the opportunity to provide comments on the proposed change to the commission rule that restricts waterfowl hunting on the Yellowstone River between the Bighorn-Yellowstone River confluence and the Rosebud-Custer County line. While I agree there is no biological basis for the regulation and it would increase hunter access on river proper, in my judgement, hunter success in the Yellowstone River Valley would suffer and that impact was not considered as part of this proposal. Protection of roosting areas on the Yellowstone keep Canada Geese in the area and the nearby Wildlife Management Areas, Block Management Areas, and cultivated school trust lands already provide large areas for hunter access for pass shooting and field hunting. Removing the restriction with a resulting increase in hunting pressure in roosting areas will redistribute the waterfowl within the reach and likely increase geese migration further south into Wyoming and reduce waterfowl available to Montana hunters. My experience with waterfowl closures at Freezeout Wildlife Management Area and on the Missouri River in Cascade County positively impact hunting opportunities and hunter success in nearby areas by providing security for roosting areas that keeps waterfowl in the area.

Examination of Figure 3 in the Hunting Season Change Supporting Information shows that even with the restriction in place, there are still large reaches of the Yellowstone and Bighorn rivers available for waterfowl hunting below the high-water mark. Additionally, the Hunting Season Change Supporting Information on the Commission's website for this issue describes the "main pulse of migrating geese reach the area the second or third week of November and the river becomes inaccessible because of ice shelves around the first or second week in December and last year ice shelves formed in mid-November". This relatively short window of hunter opportunity on the river does not represent a good tradeoff for the existing hunting opportunities available from early November till the end of the season. It's also be likely that some hunters will push their luck at icy boat ramps or on the river resulting in mishaps or accidents that will create a public safety issue for law enforcement and search and rescue staff.

Finally, Wildlife Biologist Steven J Atwood's 2013 master thesis recommended "Engaging Inside landowners and other key stakeholders such as sportsmen, in the decision making process regarding the direction of the YRC (Yellowstone River waterfowl hunting closure) policy will be essential in minimizing conflict". I'm perplexed why there was not attempts made by MFWP staff to engage inside landowners, especially Block Management Cooperators and many of the current hunters who access the area, in this process.

Thank you for your consideration and please retain the closure.

I have been talking to my fellow waterfowlers who hunt the Yellowstone corridor as described in the proposed regulations and I have come to believe that opening the Yellowstone could have negative impacts, both to the quality of hunting and to the economics of the affected communities.

By opening the river to non-stop hunting pressure, this could impact the number of birds willing to stick around for the season after being shot at while going to feed and then when coming back to roost. This unending hunting pressure will drive birds out of the area and thus, after the word gets out that there are no birds in the area, that local businesses would not see the tourism activity related to waterfowl hunting i.e. food, gas and motel expenditures.

I do not understand why the waterfowl season starts and closes so early here in Montana. I have been hunting waterfowl for over 40 years. I have been in the waterfowl hunting industry for 25 years. I do not have a degree in wildlife biology but I do have experience and first have knowledge of what is actually taking place in the last several decades of waterfowl migrations in the west and Midwest logging thousands of ours in the field. In the last 10 years the migration has been delayed due to the warmer winters we are now getting. Our majority of birds don't arrive until December with the true migration beginning in mid-November. Currently Montana waterfowl hunters miss out on a several weeks of great hunting in January. Also by opening up the season so early you are encouraging the killing of the few local ducks and geese that breed here or in southern Canada. They are young and vulnerable, only months of being alive. Flyways are constantly changing due to drought conditions in the west, hunting pressure and farming practices. This completely affects the migration and needs to be taken into account.

I suggest talking to other biologists from other nearby states and revisiting this topic take in account the changing flyways and changing climate. There are numerous states in the Central and Pacific Flyways that allow their seasons to end at the end of January and even some that go into February.

As a hunter who supports access to public lands in Montana, I can see how FWP might see opening the Yellowstone River refuge up to hunting as a win for public lands. Yet, there are many negative aspects to this happening and not many good ones. First, this refuge has been a huge conservation success story with the goose numbers doing well in this area and hunters having success, why would you want to end something that is working well? Second, in terms of access around the Yellowstone River, there are plenty of BMA areas that we have access to which having the river as a refuge increases the quality of those hunting opportunities. Third, most of the birds in this valley roost (sleep) on the river and feed in the fields. Hunting birds where they roost will cause birds to leave the area entirely instead of hunting birds in the fields where they will go back to the river and find different fields to feed in, effectively allowing both hunters to be able to hunt, and the birds being able to go back to somewhere safe. Fourth, opening the river to hunting will encourage hunters to take boats out onto the Yellowstone in dangerous conditions late into the season with ice flows and strong currents into ice dams. This would put a strain on the local EMS services and potentially put more lives at risk. This comment pertains to the "Edits to Statewide Closures on Page 59 of 2023 Migratory Bird Regulations", specific to lifting the hunting closure on the Yellowstone River from the confluence of the Bighorn River to Custer Bridge.

This proposal makes sense for several social and biological reasons:

- 1. The area from Hysham to Custer has become extremely limited access for waterfowl hunting. Outfitting and leasing has removed a large portion of private access and there are very limited public opportunities. I have hunted this area for 15 years via family friends or knocking on doors. All my previous access areas have become outfitted or leased. The ability to hunt the river provides opportunity to waterfowl hunt for average MT hunters not willing (or able) to pay thousands of \$\$\$ for a lease.
- 2. Access to hunt the river, I believe, will result in better hunting for the majority of parties by keeping birds moving all day instead of tens of thousands of birds holding on areas of the river during the day.
- 3. Mallard ducks and Canada geese compromise the vast majority of species that utilize the river in this area. Both species are near, or at, historic highs as far as populations. In fact, Canada geese populations are high enough to damage summer range in Northern areas. Potential increased harvest will not affect the future of either species and could be a benefit to the landscape in the case of Canada geese.
- 4. The birds will continue to use this section of the Yellowstone river as overwinter habitat. The nearby Bighorn river sees heavy waterfowl hunting pressure on almost all sections of the river, yet, huge flocks of Canada geese and mallards use the river during those same times. There is no reason to suggest that birds will leave this area due to hunting pressure on the river.

For these reasons I am in favor of the regulation change stated above.

As a hunter who supports access to public lands in Montana, I can see how FWP might see opening the Yellowstone River refuge up to hunting as a win for public lands. Yet, there are many negative aspects to this happening and not many good ones. First, this refuge has been a huge conservation success story with the goose numbers doing well in this area and hunters having success, why would you want to end something that is working well? Second, in terms of access around the Yellowstone River, there are plenty of BMA areas that we have access to which having the river as a refuge increases the quality of those hunting opportunities. Third, most of the birds in this valley roost (sleep) on the river and feed in the fields. Hunting birds where they roost will cause birds to leave the area entirely instead of hunting birds in the fields where they will go back to the river and find different fields to feed in, effectively allowing both hunters to be able to hunt, and the birds being able to go back to somewhere safe. Fourth, opening the river to hunting will encourage hunters to take boats out onto the Yellowstone in dangerous conditions late into the season with ice flows and strong currents into ice dams. This would put a strain on the local EMS services and potentially put more lives at risk. Lastly, the long term effect of disbanding a refuge will ultimately result in a decrease in hunter success which will decrease hunter attraction to the area which will negatively impact the local economies that rely on hunters to frequent their businesses in the winter months. I am a legacy landowner of Region 7 Yellowstone River property (both river bottom and upland agriculture). Many generations of my family and I have lived, observed and hunted this area for over 50 years. The current waterfowl management strategy along this stretch of the Yellowstone has been extremely effective, with significantly larger flocks staging and holding in these areas. When compared to the populations and behavior of waterfowl in this area to other, similar areas across Montana, North Dakota, Idaho and Colorado, there is a dramatic difference. There does not appear to be a valid basis for the proposal to lift the restriction for hunting waterfowl within the historic high water mark on the Yellowstone in this region and I would like to see the scientific assessment of the effects it would have. I can personally attest to the behavior of the birds observed on the river during the fall/winter months where they are able to recover and replenish partway through their seasonal migration. Active hunting and harassment of the flock on the river will most certainly impact the health of the waterfowl. In addition, I'm certain that it would affect the behaviors of the flocks such that the quality of hunting opportunities within the feeding areas around the river would also be significantly reduced. This type of change of what I would consider to be a successful application of governmental management should be made with much more input from both scientific and local communities. I strongly object to this proposal and urge the commission to cancel these plans until a more thorough and transparent assessment of both environmental and community impact has been completed.

MWF supports ending the closure of waterfowl hunting on the Yellowstone River from the Big Horn confluence to the Rosebud County line. This closure outlived its purpose. When it was created, the goose population in that area was under 600. Now, conservative estimates put the goose population there at over 300,000. Reopening this stretch of river will create a big opportunity for folks to hunt in an area that had become a de-facto wildlife refuge. We support ending this closure because it will open up a large, productive area for waterfowl hunting opportunities, plus it will improve wildlife managers' ability to keep goose populations from getting to numbers so high that they drastically increase crop damage in their migratory corridor. While adjacent field hunters may see geese shift their strategies as they go from water to grain and back, this opening will get geese moving more frequently and put more pressure on them in an area where population control is needed. We urge the Commission to end this closure and re-open waterfowl hunting opportunities on this 87 mile stretch of the Yellowstone.

MWF also supports the regulation changes for cranes, as well. The numbers bear out that these are sensible and conservative changes that reflect what folks and biologists are seeing on the ground.

I ADAMANTLY OPPOSE the elimination of the restrictions on waterfowl hunting on the approximately 87 mile portion of the Yellowstone River between the confluence of the Bighorn and Yellowstone Rivers to the Rosebud-Custer county line. The surveys that were done were poorly conducted and to my knowledge, out of the 2023 Survey Monkey survey that was sent to only Montana Waterfowl Stamp owners there were only 123 responses with 97 in favor of the elimination. This was a statewide survey, not just easter Montana. That does not strike me as a representative survey of an 87 mile portion of the Yellowstone River in eastern Montana. Were any landowners, business owners or outfitters in this radius contacted? As a landowner of approximately 1.5 miles of Yellowstone River frontage for 42 years, I do not know of any local landowners that were contacted. Hunting access is already permissible on land on both sides of the Yellowstone River through either block management, outfitting or permission from landowners. The restrictions on the river were put in place in 1958 (?) to replenish the lack of waterfowl on this stretch of river. Dependent on the year and weather, geese are plentiful or close to non-existent. I believe it is backassward to remove a restriction that has brought the return of geese to our area when there is plenty of hunting available on surrounding land. You have to be a bit of a fool to try to put a boat in the Yellowstone during the open season for waterfowl anyway. The river is low and prone to ice jams and other obstacles, etc. This is a pristine area of a river that has protections for the benefit of wildlife, fish and people. Allowing hunting on the water opens it up to causing more traffic and pressure on the river which is not environmentally sound for wildlife or humans. Shooting from the river will not only disrupt the waterfowl, but the bald eagles, hawks and other wildlife that take sanctuary at the river. It will cause more pressure on the geese during hunting season and close off an area which they use as a refuge. Without a refuge, the geese will once again leave this area. I believe that lifting the restrictions that were made and helped to build up a fairly stable population should be left in place. My steadfast opinion is that by lifting the restrictions would be like penning up wildlife in a corral with no refuge and allowing hunters to hunt them there. PLEASE DO NOT LIFT THESE RESTRICTIONS!! We love our geese and want them to keep coming back. Thank you.
