Our members and supporters value our fair-chase hunting heritage and the wild public lands habitat needed to support it. Our thoughts on this come from a standpoint of doing what's best for the resource and then adding opportunity where it makes sense.

We support the Blackfoot Clearwater WMA closing on Dec. 1 at 11:59 p.m as this better aligns with the unique Hunting District 282 season dates.

We support the Calf Creek WMA closing on Dec. 1 and opening at noon on May 15th, as this better aligns with other WMA seasons and takes into account the increasing development in the area and lack of suitable winter range elsewhere.

We support adding an exception for the J. Ray Kuhns WMA and opening this on April 14 at noon. As stated in the proposal, this WMA is primarily white-tailed deer winter range and by mid-April, the deer have dispersed. MWF supports adjusting these WMA open/closure dates. Most of these deal with recreationists and shed hunters disturbing elk and deer wintering grounds, while another will provide a spring turkey hunt where deer security is not an issue. Each of these modifications show that FWP is taking winter range and ungulate security into consideration when allowing the public onto these grounds, and we applaud this effort. As fun as shed hunting can be, it should not come at the expense of animal security on WMA wintering grounds. Pushing elk and deer around, and sometimes off of, these WMAs at a time when energy conservation for elk and deer is essential, and leads to unnecessary stress on animals. This can easily be mitigated through these adjustments to these specific WMA's opening dates for public access.
