HIGHLIGHTS

- Project funding generated \$3.7 million in matching dollars
- 14 projects were completed, from grant cycles between 2016-2023

UPDATES

- The 2023 Legislative Session brought \$2 Million in authority for FY2024/2025. This is an increase of approximately \$700,000.
- FWP is working to allocate all unspent Program authority. Time between project approval, construction, and billing makes this challenging, but we are on track to meet this goal.
 - All of the authority from previous Legislative Sessions (before 2023) has been allocated to new projects.
 - The Winter 2024 funding cycle (not included in this summary) includes a recommendation for \$1.12 million in grants.

NEXT STEPS

Upcoming Grant Cycles

- Three grant cycles remain in the 2024/2025 Biennium
 - Winter 2024, Summer 2024, Winter 2025
- Emphasis will be placed on spending existing authority
 - o Focus on responsible spending, priority fish habitat projects
 - Use of matching dollars to extend FFIP funds
