This letter is to express support for FWP's proposed 2024-2025 biennium regulations for the take of 10 nestling or fledged peregrine falcons for their use in falconry for Montana residents, and the take of 1 nestling or fledged peregrine falcon for use in falconry for non-residents. The demand for wild Montana peregrine falcons has historically been low, and in most cases far below the current quota. Peregrine falcon populations in Montana continue to increase and appear extremely healthy. Surveys conducted by the Montana Peregrine Institute since 2012 indicate a 50% increase in active territories, with an average of 5 new eyries discovered each year. Survey efforts have focused on areas not surveyed in the past, including the central and eastern half of the state, where 8 new territories have been found from the Big Snowy Mountains near Lewistown, MT to Hysham, MT in the eastern part of the state. Total known territories now exceed 250, with an average fledging rate of 2.2 and 2.3 young per pair for the years 2020 and 2021 respectively. This is significantly above the national average, and indicates an increasing population. Observations of sub-adults and "floater", non-paired adults indicate a healthy survival rate of young birds through their first year, and a significant number of replacement recruits when mortality of an adult occurs at a nest site.

The USFWS Environmental Assessment on falconry states that falconry has no negative impact on wild populations of raptors, nor on the prey that is hunted. Therefore, the take of young peregrine falcons for falconry in Montana at current rates can expect to have no impact on falcon populations and should be allowed to continue.
