3. Provide public access to existing logging roads in the Whitehorse track for motorized and non motorized use (ATV, bikes, snowmobiles, hike, & horseback).
4. Provide public access to existing logging roads in the Fish Creek State Park. That means no closed gates. Open gates at Mile 7 of road 341 and roads off of Williams pass junction, and roads off 341 south of the pass.
5. Provide public access to existing logging roads to connect Williams pass and the Whitehorse track.
6. Provide weed control where it is the worst.

The overall intent is to provide public access to greatest number of Montanans and other visitors who are not able to hike 10 to 20 miles of mountains.

The Shining Mountains Chapter of the Montana Wilderness Association supports the Montana Department of Fish, Wildlife and Parks proposed acquisition of the two Koch inholdings within the Fish Creek Wildlife Management Area. These parcels total 276 acres and include 1.2 miles of riparian habitat along Fish Creek.

The health of the middle Clark Fork River is directly related to the health of Fish Creek and its forks. Native Bull trout and west slope cutthroat trout spawn in the forks and tributaries of Fish Creek. Once the trout grow larger, they leave Fish Creek and spend their adult life in the Clark Fork, returning to the Fish Creek forks and tributaries to spawn.

The riparian habitat in the main stem parcel along Fish Creek (160 acres) also provides habitat for song birds and small mammals and wintering habitat for elk, mule deer, white-tailed deer, and moose.

The Great Burn Study Group (GBSG) Board of Directors and staff wish to extend our support for the proposed MTFWP acquisition of an additional 276 acres to the Fish Creek Wildlife Management Area (WMA). GBSG is a local conservation organization based in Missoula. GBSG's mission is to conserve the wild and remote character of the northern Bitterroot Mountains along the Montana/Idaho stateline. Fish Creek is of great importance to GBSG, not only because of its proximity to the proposed Great Burn Wilderness, but also because of the drainage's local and regional significance for wildlife and native fisheries.

As you know, national, regional state government wildlife agencies and other organizations have identified the Fish Creek area as a high-quality wildlife corridor and part of a regional wildlife movement zone linking the Selway-Bitterroot to the Northern Continental Divide and Selkirk-Cabinet-Yaak Ecosystems. Locally, Fish Creek is part of a wildlife linkage zone between the Ninemile Valley and the Fish Creek/Petty Creek area. In addition, a well-known wildlife movement area exists between Burdette Creek and the proposed Great Burn Wilderness which provides passage for elk moving to winter range. Also, the Fish Creek drainage is a stronghold for genetically pure westslope cutthroat trout and supports the largest fluvial bull trout population in the middle Clark Fork drainage.


GBSG supports FWP's proposal to acquire the additional acreage for the WMA. The proposed addition would provide benefits far beyond its boundaries by permanently protecting a half mile of the main stem of Fish Creek and its riparian area from habitat degradation. We have further comments and concerns below.

We urge FWP to place priority on fish and wildlife management for the Fish Creek WMA and the addition, and therefore we recommend that FWP not provide any formal development on the site. There is a developed area nearby (Forks) which should offer all the facilities needed to accommodate the public in this area.

Members of GBSG's board and staff have served on the Mineral County Resource Advisory Committee since its inception, and also own property in Mineral County. We support this acquisition as it will enable public access which we know to be an important issue for county residents. If the property were sold to a private individual, this access would be at stake.

Thank you for the opportunity to comment. This additional acquisition represents a once-in-a-lifetime opportunity to protect the quality of life in western Montana and to maintain the core values that make western Montana such a special place.

These two species spawn in the tributaries, where the young begin their growth. FWP's stated purpose for purchasing the land is to manage the important habitat (including 1.2 miles of riparian and fisheries habitat along Fish Creek) for deer, elk and other wildlife, and to prevent this habitat from potentially being developed or subdivided.



I strongly support the Fish Creek Wildlife Management Area Proposed Acquisition of Koch Inholdings, as described in the March 2018 environmental analysis. This is an exceptional chance to obtain key recreational land for the public and to conserve top-notch fish and wildlife habitat. The proposal also helps protect the considerable existing public investment in the Fish Creek WMA.

We are fortunate that the current private landowner is willing to sell these parcels at their appraised value. The alternative — which we have seen in too many areas across Montana that have similar stream and forest attributes — is for these lands to be developed with second homes, locked gates, and no-trespassing signs. Also as we have seen across Montana, that kind of development damages public recreation and fish & wildlife habitat over a much larger area than just the developed acreage, removing many square miles from hunting and other recreation when homes are built in the middle of an expanse of public open space.

Stream parcels with the quality of Fish Creek are rare and often much more expensive than proposed here. Moreover, easily accessible stream parcels (like this one on Fish Creek) provide great family recreation opportunities, supporting our kids and maintaining the public outdoor heritage that all Montanans value so highly.

This is a good deal and the public will obtain great benefit from its approval. Thanks for putting it together and for the opportunity to comment. I urge the decisionmakers at all levels to move forward on this project and complete this land acquisition.

Montana Fish Wildlife and Parks (FWP) proposes to acquire fee title to approximately 276 acres from a private party, as an addition to FWP's adjacent 35,041-acre Fish Creek Wildlife Management Area (FCWMA). FWP's stated purpose for purchasing the land is to manage the important habitat (including 1.2 miles of riparian and fisheries habitat along Fish Creek) for deer, elk and other wildlife, and to prevent this habitat from potentially being developed or subdivided.

Representing our approximately 4,300 members statewide, Montana Trout Unlimited (MTU) enthusiastically supports this proposal, based on the high value for fish and wildlife and the increased public access and recreational opportunities in managing the property as part of FCWMA.

MTU has actively worked on both public and private land in the Fish Creek watershed and continues to consider Fish Creek as a high priority area for conservation, protection, and restoration of aquatic resources in the Clark Fork River basin, including native westslope cutthroat trout. Along with our national TU partners, MTU has developed, funded and implemented numerous projects in Fish Creek, including the decommissioning of more than 100 miles of abandoned logging roads, removal of more than 70 culverts or stream crossings and instream habitat restoration on more than 5 miles of mainstem Fish Creek.

Five Valleys Land Trust (Five Valleys) supports the proposed 276-acre Koch addition to the 35,041-acre Fish Creek Wildlife Management Area (Fish Creek WMA). The proposed addition would conserve important fish and wildlife habitat and connectivity, provide additional public access, and improve Montana Fish, Wildlife and Parks' (FWP) management of the Fish Creek WMA.

When FWP acquired the Fish Creek WMA from The Nature Conservancy as part of the Montana Legacy Project, there were several key private inholdings that were not included in the conservation effort. The unprotected status of these parcels threatens the connectivity that is essential for fish and wildlife, especially for bull trout recovery. The proposed addition would permanently protect a significant reach of Fish Creek from habitat degradation and would facilitate future enhancement activities. Outside of the Blackfoot, Fish Creek is the most important stronghold for bull trout in the middle Clark Fork region and many of the bull trout found in the Clark Fork are reared in Fish Creek. An intact migratory corridor and rearing area in the main stem is vital to this bull trout population. In addition to the fisheries values, the riparian and upland habitats on the proposed addition provides habitat for a suite of species, including: moose, grizzly bear, wild turkey, little brown myotis, rufous hummingbird and flammulated owls. Also, the connectivity of the Whitehorse Gulch parcel provides an important migratory corridor for elk and mule deer between summer and winter ranges. Providing well-managed public access to these exceptional conservation values will benefit the citizens of Montana.

Five Valleys has partnered with FWP on multiple projects within the Fish Creek drainage to transition these critical parcels from private to public ownership. In 2016, FWP requested Five Valleys' assistance in acquiring the Koch properties in order to protect its conservation values and provide additional public access and opportunities. We appreciate the opportunity to work once again with FWP to protect this special place for people, and fish and wildlife.

Please accept our comments on the Fish Creek Wildlife Management Area Draft EA from the Ninemile Wildlife Workgroup.

The Ninemile Wildlife Workgroup is a group of Huson/Ninemile/Alberton residents and others committed to promoting knowledge and stewardship of wildlife and habitats within these communities and surrounding public lands. Details about our organization can be found on our website: <http://www.ninemilewildlife.org/>. Much of our mission area is a Forest Service demographic connectivity area for grizzly bears and all of it is an important connectivity area between the Bitterroot, the Northern Continental Divide, and the Selway/Cabinet Yaak ecosystems. This area provides a biological bridge permitting migration and genetic exchange between these vast islands of security for far-ranging species of wildlife to persist.

The lands of the Fish Creek State Park and Wildlife Management Area are a critical component of the bridge between these ecosystems. We have previously commented on Fish Creek State lands on February 6, 2014, and on November 6, 2015 and we remain interested in the management of this area. Many in our group commonly use this area for a variety of recreational pursuits such as fishing, hunting, and wildlife viewing. Some of us have read your EA and have attended the public meeting in Alberton on March 22, 2018.

Most importantly to the Ninemile Wildlife Workgroup is that the habitat for wildlife and fish, and the wild characteristics of Fish Creek are enhanced and protected. Adding the two parcels as described in alternative B would best protect these values and we fully endorse the adoption of Alternative B. Adding these parcels would block up an additional 276 acres into public ownership, enhancing the value of these lands for the fish and wildlife and for the people who enjoy them. The parcel along the main stem of Fish Creek is especially important to maintain the premier bull trout and westslope cutthroat trout fish habitat while protecting it from private development. Acquiring this piece would provide additional parking and accessibility to a relatively flat and open section of the creek that families and the elderly could enjoy. Both parcels currently do not allow public access. Adding them to the Wildlife Management Area would augment recreation opportunities and increase visitation that will help the economy of surrounding communities.

The Board of Directors of the Ninemile Wildlife Workgroup requests that you select alternative B and acquire the two Koch properties.
