## GENERAL INFORMATION

The Naegeli Ranch Block Management Area (BMA) is located in Sanders County, northwest of Thompson Falls. Hunting on 920 acres is provided by the Naegeli Ranch.

This BMA offers hunting opportunities for white-tailed deer, mule deer, elk, black bear, upland game birds, waterfowl and turkey.

## PERMISSION REQUIREMENTS

Written permission is required to hunt on this BMA. To receive permission stop by the ranch house or call (406) 827-4887 **during daylight hours**. Please do not contact the landowner at any other time but during daylight hours.

## HOW TO GET THERE

➔ From Thompson Falls, travel north on Highway 200 about 11 miles to Beaver Creek Road;

➔ Turn west onto Beaver Creek Road and travel 0.8 miles to the intersection with Little Beaver Creek Road;

➔ Turn south onto Little Beaver Creek Road and travel 0.4 miles before turning west onto the BMA access road leading to the ranch house.

## REGULATIONS

1. Motorized vehicle travel is not allowed on this BMA. Non-motorized travel is open to foot, horseback, and bicycle only.
2. Do not park vehicle in such a manner as to obstruct traffic. Do not block gates.
3. It is unlawful to commercially outfit on this BMA.
4. Failure to abide by the regulations for this BMA can result in a trespass violation under MCA 45-6-203 and/or a violation of FWP Department or Commission orders or rules under MCA 87-6-201.


