Open Fridays-Mondays, Closed Tuesdays-Thursdays

GENERAL INFORMATION

The Kohler Lake Block Management Area (BMA) is located in Flathead County north of Bigfork. Hunting on 160 acres is provided entirely by a private landowner.

This BMA offers hunting opportunities for black bear, white-tailed deer, mule deer, elk, upland game birds, waterfowl, and turkey.

PERMISSION REQUIREMENTS

Written permission is required to hunt on this BMA and hunter numbers are limited.

Hunter numbers are limited to 1 hunting party per day. A hunting party may consist of up to 3 people. The BMA will be open Fridays-Mondays and closed Tuesdays – Thursdays. Permission is administered at the Region 1 FWP office in Kalispell, for more information call 752-5501.

HOW TO GET THERE

➔ From Bigfork, travel 7 miles north on Highway 35 to La Brant Road;

➔ Turn east onto La Brant Road and travel 1.3 miles to Old Timber Trail;

➔ Turn north onto Old Timber Trail and travel 0.4 miles to the BMA Parking Area.

REGULATIONS

1. All access is walk-in only from the designated parking area. All other roadways are private driveways and are closed to hunters.
2. This area is for shotgun, muzzleloader, traditional handgun, and archery equipment only. No rifles.
3. It is unlawful to commercially outfit on this BMA.
4. Failure to abide by the regulations for this BMA can result in a trespass violation under MCA 45-6-203 and/or a violation of FWP Department or Commission orders or rules under MCA 87-6-201.


