## GENERAL INFORMATION

The Columbia Falls Aluminum Co. (CFAC) Block Management Area (BMA) is located in Flathead County, just east of Columbia Falls. Hunting opportunity is provided by CFAC on 900 acres.

This BMA offers hunting opportunities for white-tailed deer, mule deer, elk, upland game birds, black bear, and turkey.

*This area is only for youth hunters and hunters that possess a Permit to Hunt From a Vehicle (PTHFV).*

## PERMISSION REQUIREMENTS

### **Hunting allowed Thursday-Sunday ONLY**

Written permission is required to hunt on this BMA, and hunter numbers are limited to 1 party of 4 hunters per day.

Permission for the General Rifle season is via drawing through the FWP Region 1 office in Kalispell. Applications will be taken during September. Successful applicants will be notified the 1<sup>st</sup> week of October. For more information contact the Region 1 office at (406)752-5501, Mon – Fri, 8AM – 5PM.

## REGULATIONS

1. This BMA is only for youth hunters and hunters with a Permit to Hunt From a Vehicle.
2. Hunters are required to park in designated parking areas.
3. No off road vehicle travel is allowed, this includes ATVs and motorcycles. Please stay on designated roads.
4. No camping, camp fires, or wood cutting allowed.
5. Littering is prohibited. Pack it in – pack it out.
6. It is unlawful to commercially outfit on this BMA.
7. Failure to abide by the regulations for this BMA can result in a trespass violation under MCA 45-6-203 and/or a violation of FWP Department or Commission orders or rules under MCA 87-6-201.


