Deer/Elk Hunting District (HD) 260

Hunting Access Dates: September 1, 2016 – January 15, 2017

GENERAL INFORMATION

The Unruh Ranch Block Management Area (BMA) is located approximately 2 miles south of Victor in Ravalli County. Hunting is provided by private landowners on approximately 66 acres in the Bitterroot River bottom.

This BMA provides opportunities for hunting upland bird, white-tailed deer and waterfowl in HD 260.

WEAPON RESTRICTIONS:

This BMA is within a weapon restricted hunting district (HD 260). **Rifle use is prohibited.**

PERMISSION REQUIREMENTS

Every hunter is required to **register daily at one of the sign-in boxes before beginning to hunt.** Registration details are posted on-site at each sign-in box.

HOW TO GET THERE

From US Highway 93 south;

➔ Turn east at the Tucker Crossing Fishing Access Site (FAS) entrance.

➔ From Tucker FAS, walk south to the sign-in box.

REGULATIONS

1. Rifle use is prohibited. Hunting with shotgun, muzzleloader, traditional handgun, or archery equipment is allowed.
2. Access to this BMA is walk-in only from designated parking areas and sign-in boxes.
3. Drive-in game retrieval is allowed on the Unruh Ranch BMA, with prior permission.
4. Do not park vehicles in such a manner as to obstruct traffic. Do not block gates.
5. Camping is not allowed on this BMA.
6. Do not enter ranch buildings, corrals or other structures. Keep away from residences.
7. It is unlawful to commercially outfit on these BMAs.
8. Failure to abide by the regulations for these BMAs can result in a trespass violation under MCA 45-6-203 and/or a violation of FWP Department or Commission orders or rules under MCA 87-6-201.


