LITTLE BEAVER CREEK RANCH BMA #13

Deer/Elk Hunting District: 201

Black Bear Management Unit: 200

Hunting Access Dates: September 1 - November 27, 2016

GENERAL INFORMATION

Little Beaver Creek Ranch Block Management Area (BMA) is located in the Ninemile Valley of Missoula County, approximately 23 miles northwest of Missoula. Hunting is provided by private landowners on 1,480 acres.

This BMA offers hunting opportunities for white-tailed deer, mule deer, elk, black bear, wolf, and mountain grouse. A portion of this BMA is only open to archery hunting.

PERMISSION REQUIREMENTS

Written permission is required to hunt on this BMA and hunter numbers are limited.

To receive permission contact the Little Beaver Creek Ranch headquarters between the hours of 8 AM and 6 PM. Call (406) 626-0058 to obtain a permission slip.

After receiving written permission, every hunter is required to register daily at the sign-in box before beginning to hunt. Registration details are posted on site at the sign-in box.

HOW TO GET THERE

Drive west on Interstate Highway 90 (I-90) approximately 20 miles from Missoula.

➔ Take Ninemile exit #82; on the north side of I-90, proceed west. Turn right (north) onto Remount Road. Continue on Remount Road for approximately 5 miles towards the Ninemile Ranger Station;

➔ At the 4-way junction south of the Ranger Station, turn right (east) to access the Little Beaver Creek Ranch buildings along the road at the top of the hill.

REGULATIONS

1. Motorized vehicle travel is not allowed on this BMA while hunting. Hunters may gain vehicle access for game retrieval purposes after first getting permission from ranch personnel.
2. Do not park vehicles in such a manner as to obstruct traffic. Do not block gates.
3. Camping is not allowed on this BMA.
4. It is unlawful to commercially outfit on this BMA.
5. Failure to abide by the regulations for this BMA can result in a trespass violation under MCA 45-6-203 and/or a violation of FWP Department or Commission orders or rules under MCA 87-6-201.


