GENERAL INFORMATION

The Warnken Ranch Block Management Area (BMA) is located in Mineral County northwest of Superior. Hunting is provided by a private landowner on 715 acres.

This BMA provides hunters access to adjacent federal lands, as well as hunting opportunities for white-tailed deer, mule deer, elk, black bear, wolf, and mountain grouse.

There are two separate units for this BMA:

- Unit 1 is located in **Sections 14 and 23**
- Unit 2 is located in **Section 8**

PERMISSION REQUIREMENTS

Written permission is required to hunt this BMA. To receive permission: call the ranch at (406)822-4322 between 4:00 PM and 8:00 PM to make an appointment to receive a season-long permission slip.

Each hunter must carry the season-long permission coupon at all times while hunting on this BMA.

Permission slips are valid from September 1 through November 27, 2016 on the Warnken Ranch BMA.

HOW TO GET THERE

On Interstate Highway 90 (I-90) about 4 miles west of Superior (60 miles west of Missoula),

- ➔ Take the Dry Creek exit (#43) and continue to the north side of I-90.
- ➔ Then take the first left (Southside Road) after the westbound ramp entrance, but before the river.
- ➔ From the start of Southside Road, proceed about 1.7 miles to the Ranch Headquarters.

REGULATIONS

1. Motorized vehicle travel is not allowed on this BMA.
2. Allowable travel is by foot, horseback or non-motorized bike.
3. Do not park vehicles in such a manner as to obstruct traffic. **DO NOT BLOCK GATES.**
4. Camping is not allowed on this BMA.
5. It is unlawful to commercially outfit on this BMA.
6. Failure to abide by these regulations can result in a trespass violation under MCA 45-6-203 and/or a violation of FWP Department or Commission orders or rules under MCA 87-6-201.


