Hunting Access Dates: September 3, 2016 – January 15, 2017

**Hunting is NOT allowed on Sundays**

## GENERAL INFORMATION

The Running E-T Ranch Block Management Area (BMA) is located in Ravalli County southwest of Stevensville. This 160 acre BMA primarily offers hunting opportunities for white-tailed deer and occasionally for mule deer, elk, black bear, wolf, upland birds, and turkey.

This BMA has weapon restrictions. Rifle hunting is PROHIBITED due to the close proximity to houses.

Hunter numbers are limited and hunting is not allowed on Sundays.

## PERMISSION REQUIREMENTS

Written permission is required to hunt on this BMA. Only one hunting party is allowed access per day and the ranch is closed to hunting on Sundays. To arrange to receive a permission slip, call the ranch at (406) 642-3286 during reasonable hours.

After receiving written permission, every hunter is required to register *daily* at the sign-in box *before* beginning to hunt. Registration details are posted on-site at each sign-in box.

Every hunter must carry the daily permission coupon at all times while hunting on this BMA.

## HOW TO GET THERE

On US Highway 93 about 4 miles north of Victor, take Indian Prairie Loop Road for 1.4 miles to St. Mary's Road; take St. Mary's Road north ½ mile to the junction of Lookout Trail and the BMA sign-in box.

## REGULATIONS

### 1. Weapon Restrictions:

Hunting on the Running E T Ranch BMA is restricted to shotgun, muzzleloader, handgun and archery equipment only. Rifle hunting is PROHIBITED. (See accompanying map)

2. Access is walk-in only from the designated parking area and sign-in box.
3. Do not park vehicles in such a manner as to obstruct traffic. Do not block gates.
4. Do not enter ranch buildings, corrals or other structures. Keep away from residences.
5. Camping is not allowed on this BMA.
6. It is unlawful to commercially outfit on this BMA.
7. Failure to abide by the regulations for this BMA can result in a trespass violation under MCA 45-6-203 and/or a violation of FWP Department or Commission orders or rules under MCA 87-6-201.


