## GENERAL INFORMATION

The Case Ranch Block Management Area (BMA) is located near Potomac in Missoula County, approximately 20 miles east of Missoula. Hunting is provided by a private landowner on approximately 2,495 acres.

This BMA provides hunting opportunity for white-tailed deer, mule deer, elk, black bear, wolf, and mountain grouse. This BMA also provides hunters with access to adjacent state lands.

## PERMISSION REGULATIONS

Written permission is required to hunt this BMA. Between 8:00 AM and 8:00 PM call the ranch at (406) 244-5521 to arrange to receive a permission slip (*please do not call between 6:00 & 7:00 PM*).

After receiving written permission, every hunter is required to register daily at one of the sign-in boxes before beginning to hunt.

Every hunter must carry the daily permission coupon at all times while hunting on this BMA.

## HOW TO GET THERE

From Missoula go east on Interstate 90 about 4 miles; take Bonner exit #109 and proceed easterly on Montana Highway 200 about 16 miles to:

➔ Two sign-in boxes for the Case Ranch are located about 2 miles east of Potomac along Montana Highway 200.

## REGULATIONS

1. Motorized vehicle travel is not allowed on this BMA. Access is only allowed on foot, horseback or non-motorized bicycle.
2. Do not park vehicles in such a manner as to obstruct traffic. **DO NOT BLOCK GATES.**
3. Drive-in game retrieval is allowed on this BMA with prior permission from the landowner.
4. Ask about camping on this BMA when receiving permission from the ranch.
5. Do not enter ranch buildings, corrals, or other structures.
6. It is unlawful to commercially outfit on these BMAs.
7. Failure to abide by the regulations for these BMAs can result in a trespass violation under MCA 45-6-203 and/or a violation of FWP Department or Commission orders or rules under MCA 87-6-201.


