## GENERAL INFORMATION

The Stitt Ranch Block Management Area (BMA) is located in Powell County between Helmsville and Avon. Hunting is provided by a private landowner on 450 acres.

This BMA offers hunting opportunities for white-tailed deer, mule deer, elk, black bear, wolf, and mountain grouse. This BMA also provides hunters access to adjacent state lands.

**ELK RIFLE HUNTING IS ONLY ALLOWED OCTOBER 22 – NOVEMBER 27.**

## PERMISSION REQUIREMENTS

Verbal permission is required to hunt this BMA. To obtain verbal permission call the Stitt Ranch during reasonable hours at (406)793-5533 or stop by the ranch to request permission.

After receiving verbal permission, each hunter is required to sign in daily at the sign-in box before beginning to hunt. The Stitt Ranch sign-in box is located along the *Nevada Creek Ranch Road* that follows the Douglas Creek Canal.

## HOW TO GET THERE

From Missoula go east on Interstate 90 approximately 60 miles to the junction of Montana Highway 200 and Montana Highway 141:

➔ Turn southeast on Highway 141 and drive approximately 11 miles to the Stitt Ranch entrance on the south side of the road.

## REGULATIONS

1. Limited motorized vehicle travel is allowed on this BMA while hunting. Check with the landowner for specific vehicle-use restrictions.
2. Do not park vehicles in such a manner as to obstruct traffic. Do not block gates.
3. Camping is not allowed on the Stitt Ranch BMA.
4. It is unlawful to commercially outfit on this BMA.
5. Failure to abide by the regulations for this BMA can result in a trespass violation under MCA 45-6-203 and/or a violation of FWP Department or Commission orders or rules under MCA 87-6-201.


