## GENERAL INFORMATION

The Upper Mulkey Gulch BMA is located northwest of Drummond in Granite County. Hunting on about 320 acres is provided by a private landowner.

This BMA offers hunting opportunities for elk, mule deer, white-tailed deer, black bear, wolf, turkey and mountain grouse.

## PERMISSION REQUIREMENTS

Every hunter is required to register *daily* at the sign-in box *before* beginning to hunt on this BMA. Registration details are posted on-site at the sign-in box.

Every hunter must carry the daily permission coupon at all times while hunting on this BMA.

## HOW TO GET THERE

### **From Missoula:**

Drive east on I-90 approximately 33 miles to the Bearmouth exit #138. Head north from the exit; continue on the *Frontage Road* east for approximately 2 miles.

➔ Turn north (left) on Bear Creek Road and continue for approximately 4 miles. Take a sharp right (east) on Upper Mulkey Gulch Road. Follow Upper Mulkey Gulch Road for approximately 1 mile to BMA boundary.

## REGULATIONS

1. Motorized vehicle travel is only allowed on roads that are designated on the accompanying map. Travel on other roads, as well as off-road travel, is restricted to foot, horseback or non-motorized bicycle.
2. Be prepared to retrieve game by non-motorized methods.
3. Do not enter or shoot into any Safety Zone. There may be Safety Zones posted on this BMA that are not indicated on the map.
4. Do not park any vehicle in such a manner as to obstruct traffic or block any gate.
5. No open fires. No camping. No firewood cutting.
6. It is unlawful to commercially outfit on this BMA.
7. Failure to abide by the regulations for this BMA can result in a trespass violation under MCA 45-6-203 and/or a violation of FWP Department or Commission orders or rules under MCA 87-6-201.


