GENERAL INFORMATION

The Thomas Hereford Ranch Block Management Area (BMA) is located about 13 miles southeast of Drummond in Powell County. Hunting on about 800 acres is provided by a private landowner.

This BMA offers hunting opportunities for white-tailed deer, mule deer, elk and occasionally for black bear, wolf and mountain grouse.

ELK RIFLE HUNTING ALLOWED FROM SEPTEMBER 1, 2016 – JANUARY 1, 2017.

PERMISSION REQUIREMENTS

Written permission is required to hunt on this BMA and the number of hunters is limited to 8 per day.

To receive a permission slip call the Thomas Hereford Ranch during reasonable hours at (406) 288-3459 or stop by the ranch.

After receiving written permission, each hunter is required to register *daily* at the sign-in box located in the ranch compound *before* beginning to hunt. Registration details are posted on site at the sign-in box.

HOW TO GET THERE

On Interstate Highway 90 (I-90) about 13 miles east of Drummond and about 60 miles east from Missoula,

➔ Take Gold Creek exit #166; drive south on Gold Creek Road about 1 mile to the ranch entrance.

REGULATIONS

1. **September 1 – October 21:**
Hunters are only allowed to harvest cow elk during this time.
2. Limited motorized vehicle travel is allowed on this BMA. Ask for specific vehicle-use restrictions and game retrieval policy when receiving your permission slip.
3. Do not block any gate or park any vehicle in such a manner that obstructs traffic.
4. Camping is not allowed on this BMA.
5. It is unlawful to commercially outfit on this BMA.
6. Failure to abide by the regulations for this BMA can result in a trespass violation under MCA 45-6-203 and/or a violation of FWP Department or Commission orders or rules under MCA 87-6-201.


