Hunting Access Dates: September 1 - November 27, 2016

GENERAL INFORMATION

The Hope Creek Block Management Area (BMA) is located in Lewis and Clark County, about 9 miles north of Elliston. Hunting on 1,600 acres is provided by a private landowner.

This BMA offers hunting opportunities for white-tailed deer, mule deer, moose, wolf and elk. This BMA also provides access to adjacent federal lands.

PERMISSION REQUIREMENTS

Every hunter is required to register daily at one of the sign-in boxes before beginning to hunt on this BMA. Registration details are posted on site at the sign-in boxes.

Every hunter must carry the daily permission coupon at all times while hunting on this BMA.

HOW TO GET THERE

From Missoula: Go east on Interstate Highway 90 about 70 miles to the Garrison exit #174;

▶ Drive east on US Highway 12 about 25 miles to the Mullan Pass Road (Dog Creek drainage).

▶ Travel north on Mullan Pass Road to USFS 571.

▶ Take USFS 571 for approximately 6 miles to the BMA boundary.

From Helena: Go west on US Highway 12 about 8 miles to the Priest Pass Road (Forest Service Road #335, Sweeney Creek drainage);

▶ Drive northwesterly on Priest Pass Road about 9 miles to Mullan Pass Road.

▶ Travel north on Mullan Pass Road to USFS 571.

▶ Take USFS 571 for approximately 6 miles to the BMA boundary.

REGULATIONS

1. Motorized vehicle travel is not allowed on this BMA. Hunters should park along designated Forest Service roads on accompanying map. Hunters should also be prepared to retrieve game by non-motorized methods.
2. Non-motorized travel is open only to foot, horseback or non-motorized bicycle.
3. Do not park vehicles in such a manner as to obstruct traffic. Do not block gates.
4. It is unlawful to commercially outfit on this BMA.
5. Camping is not allowed on this BMA.
6. Failure to abide by these regulations can result in a trespass violation under MCA 45-6-203 and/or a violation of FWP Department or Commission orders or rules under MCA 87-6-201.


