## GENERAL INFORMATION

The Moose Lake Road Block Management Area (BMA) is located in Granite County, about 15 miles southwest of Philipsburg. Hunting on 480 acres is provided by private landowners.

This BMA offers hunting opportunities for mule deer, white-tailed deer, elk, moose, black bear, wolf and mountain grouse, as well as access to adjacent federal lands.

## PERMISSION REQUIREMENTS

Every hunter is required to register *daily* at one of the sign-in boxes *before* beginning to hunt on this BMA. Registration details are posted on site at each sign-in box.

Every hunter must carry the daily permission coupon at all times while hunting on this BMA.

## HOW TO GET THERE

At Philipsburg, go south on Montana Highway 1 about 6 miles to the junction with Montana Highway 38;

➔ Turn southwest on Highway 38 about 8 miles to Moose Lake Road.

➔ Turn south (left) on *Moose Lake Road* (USFS Road # 5106); Look for the "Moose Lake" and "Copper Creek Campground" sign.

➔ Go south on the Moose Lake Road for about 5 miles to the BMA sign-in box.

## REGULATIONS

1. Motorized vehicle travel is not allowed on this BMA. Access is by foot, horseback or non-motorized bicycle only.
2. Do not park vehicles in such a manner as to obstruct traffic. Do not block gates.
3. Camping is not allowed on this BMA.
4. No campfires or woodcutting.
5. It is unlawful to commercially outfit on this BMA.
6. Failure to abide by the regulations for this BMA can result in a trespass violation under MCA 45-6-203 and/or a violation of FWP Department or Commission orders or rules under MCA 87-6-201.


