## GENERAL INFORMATION

The Cobb Ranch Block Management Area (BMA) is located south and southeast of Hamilton in Ravalli County. Hunting is provided by a private landowner on 280 acres in Hunting District 270.

This BMA provides opportunities primarily for mule deer and occasionally for white-tailed deer and mountain grouse.

## PERMISSION REQUIREMENTS

Verbal permission is required to hunt on this BMA. Reservations are limited to one hunting party per day. To receive permission: call the ranch at 406-363-6984 between 6 P.M. and 10 P.M.

After receiving verbal permission, **every hunter is required to register daily at the sign-in box** located along Sleeping Child Road, before beginning to hunt. Registration details are posted on site at the sign-in box.

## HOW TO GET THERE

Drive about 2 miles south of Hamilton on US Highway 93 to Montana Highway 38 (Skalkaho Road);

➔ Drive south on Highway 38 for 0.7 miles to Sleeping Child Road.

➔ Head south on Sleeping Child Road for approximately 5 miles south and east to the Cobb BMA, look for the sign-in box.

## REGULATIONS

1. Motorized vehicle travel is not allowed on the BMA. Access is by foot only.
2. Do not park vehicles in such a manner as to obstruct traffic. Do not block gates.
3. Camping is not allowed on this BMA.
4. Commercial outfitting is prohibited on this BMA.
5. Failure to abide by the regulations for this BMA can result in a trespass violation under MCA 45-6-203 and/or a violation of FWP Department or Commission orders or rules under MCA 87-6-201.


