September 24-25 2016 (Youth Waterfowl Season)

## GENERAL INFORMATION

The Loisel Lane Block Management Area (BMA) is located in Missoula County, approximately 10 miles northwest of Missoula. Hunting on 33 acres is provided by a private landowner.

This BMA offers hunting opportunities for waterfowl only.

## PERMISSION REQUIREMENTS

Every hunter is required to register *daily* at the sign-in box before beginning to hunt on this BMA. Registration details are posted on site at the sign-in box. Every hunter must carry the daily permission coupon at all times while hunting on this BMA.

Hunters must park at the designated parking area, see attached map. Only one vehicle/hunting party is allowed at the parking area at any time. A hunting party may consist of no more than 4 hunters.

If there is a vehicle or hunting party at the parking area, then no further access is allowed until that vehicle/hunting party has left.

## HOW TO GET THERE

From Missoula, drive west on I-90 for approximately 8 miles, then take exit #96.

➔ Turn left on US-93/MT-200, crossing over the interstate.

➔ Turn right onto MT-474/Old US-10/Pulp Mill Rd. Follow MT-474 past the Smurfit-Stone Container plant for approximately 3.5 miles to the BMA on the left.

## REGULATIONS

1. Motorized travel is not allowed.
2. Hunters are allowed to set up decoys but they may not be left overnight. FWP and/or landowners are not responsible for theft or destruction of decoys or other personal property.
3. Temporary waterfowl blinds may be set up, but permanent blinds are not allowed.
4. Non-toxic shot must be used while hunting waterfowl.
5. No camping or campfires allowed on this BMA.
6. It is unlawful to commercially outfit on this BMA.
7. Failure to abide by the regulations for this BMA can result in a trespass violation under MCA 45-6-203 and/or a violation of FWP Department or Commission orders or rules under MCA 87-6-201.


