## GENERAL INFORMATION

The Pearson Ranch Block Management area is located in Mineral County outside St. Regis and about 70 miles northwest of Missoula. Hunting on 250 acres is provided by a private landowner.

This BMA provides hunting opportunities for white-tailed deer, mule deer, elk, black bear, wolf, mountain grouse, waterfowl, moose and black bear. It also provides access to adjacent federal lands.

## PERMISSION REQUIREMENTS

Written permission is required to hunt on this BMA. To receive a permission slip call the Pearson Ranch during reasonable hours at (406) 280-0054 to make an appointment to get written permission.

## HOW TO GET THERE

From the 4-way stop at St. Regis (north of Interstate Highway 90),

➡ Drive northwest (left) onto Mullan Gulch/Camel's Hump Road about 0.6 mile to Little Joe Road;

➡ Turn left onto Little Joe and drive approximately 1.1 miles on Little Joe (road goes over I-90) to the ranch house at 4 Big Game Crossing.

## REGULATIONS

1. Motorized vehicle travel is not allowed on this BMA while hunting. Be prepared to park and walk. Check with the landowner for any roads and/or designated parking areas for access.
2. Drive-in game retrieval is allowed with prior permission from the landowner.
3. Do not park vehicles in such a manner as to obstruct traffic. Do not block gates.
4. Camping is not allowed on this BMA.
5. It is unlawful to commercially outfit on this BMA.
6. Failure to abide by the regulations for these BMAs can result in a trespass violation under MCA 45-6-203 and/or a violation of FWP Department or Commission orders or rules under MCA 87-6-201.


