GENERAL INFORMATION

The Purcell Ranch Block Management Area (BMA) is located near Lolo in Missoula County, approximately 19 miles southwest of Missoula. Hunting is provided by a private landowner on 178 acres.

This BMA provides hunting opportunity for white-tailed deer, mule deer, elk, black bear, wolf and fall turkey.

Grouse hunting is NOT allowed.

PERMISSION REGULATIONS

Hunting access is limited to 3 hunters per day.

Written permission is required to hunt this BMA. Between 7:30 P.M and 9:30 P.M., call the ranch at (406) 273-0774 to arrange to receive a permission slip. Please leave a message if necessary.

After receiving written permission, every hunter is required to register daily at the Purcell Ranch sign-in box before beginning to hunt.

HOW TO GET THERE

From Missoula go south on Highway 93 to Lolo; turn west (right) on Highway 12 / Lolo Creek Road for approximately 6.5 miles:

➔ Turn south (left) on Mill Creek Road; continue ½ mile to the fork.

➔ At the fork turn east (left) on Severin Meadows Trail; continue on Severin Meadows Trail to ranch headquarters.

REGULATIONS

1. Hunting in the *Archery ONLY Area* is restricted to archery equipment only. Rifle hunting is NOT allowed on this portion of the BMA. (see accompanying map)
2. Motorized vehicle travel is not allowed on this BMA. Non-motorized travel is open to foot, horseback, and bicycle only.
3. Hunters must access the BMA from the **DESIGNATED PARKING AREA.**
4. Do not trespass or shoot into Safety Zones.
5. Do not park vehicles in such a manner as to obstruct traffic. **DO NOT BLOCK GATES.**
6. Drive-in game retrieval is allowed on this BMA with permission from the landowner.
7. No camping and no fires allowed.
8. Do not enter ranch buildings, corrals, or other structures.
9. It is unlawful to commercially outfit on BMA.
10. Failure to abide by the regulations for these BMAs can result in a trespass violation under MCA 45-6-203 and/or a violation of FWP Department or Commission orders or rules under MCA 87-6-201.


