**Maps to have before you go:** This BMA Map, available free at Butte, Bozeman & Helena Area FWP offices, **AND** the Beaverhead/Deerlodge National Forest Travel Plan 2008 (Central) & Beaverhead/Deerlodge National Forest Travel Plan 2008 (North), available for purchase through any Forest Service or Bozeman & Helena Area FWP offices.

**Road Use:** Vehicle travel permitted only on designated roads. Please refer to the Beaverhead/Deerlodge National Forest Travel Plan 2008 (Central) & Beaverhead/Deerlodge National Forest Travel Plan 2008 (North) for road use information on all roads outside of block management area boundaries.

**How to get there:** From Whitehall, go North on Whitehall-Boulder Road 4.5 miles to Ridder Lane on Left. Follow road past 2 story blue house with red roof. Turn left after this house. Please do not take the road before this house at landowners request. Sign-In Box will be at bottom of hill on right. From Hwy 2, take Sheep Camp Rd. 3 miles west of Whitehall. Travel north for 3 miles to Ranch boundary and Sign-In Box.


## **Ranch Rules:**

- Written permission on site from Sign-In Box locations. See map for box locations. Each hunter must carry permission stub on them while hunting.
- No motorized vehicles off designated roads.

**How to get there:** From Wise River, take the Wise River Polaris Scenic Byway for Approx 8 miles until you reach the BMA access.


## **Ranch Rules:**
