Huntible Game: White-Tailed Deer, Mule Deer, Elk, Antelope, Moose, Waterfowl & Upland Birds

Dates BMA is open: Legal Fall Hunting Seasons for White-Tailed Deer, Mule Deer, Elk, Antelope, Moose, Waterfowl & Upland Birds. Refer to current hunting regulations for specific season information.

Maps to have before you go: This BMA Map, available free at Butte, Bozeman & Helena Area FWP offices, **AND** the Beaverhead/Deerlodge National Forest Travel Plan 2008 (Central & South), available for purchase through any Forest Service or Bozeman & Helena Area FWP offices.

Road Use: Vehicle travel permitted only on designated roads. Please refer to the Beaverhead/Deerlodge National Forest Travel Plan 2008 (Central & South) for road use information on all roads outside of block management area boundaries.

How to get there: Ruby-Dell Ranch - Travel 4.8 miles south of Alder on Upper River Road, take Anderson Lane to the shop located on BMA map. Lueck Ranch - This ranch can be accessed South of Alder via Williams Creek Road to Dryden Road or by Davey Creek Road.

Ranch Rules:


- Ruby River Unit: Permission is required and can be obtained by calling Jay Peterson at (406) 596-1986 between 8:00a.m. - 7:00p.m.. Permission can also be obtained in person on site at the Anderson Ranch located 4.8 miles south of Alder on Anderson Lane at the shop location indicated on the BMA map. Permission will be granted on a first come first serve basis 24 hours prior to hunt. Please do not leave messages, phone messages will not be returned.
- Failure to cancel reservations may limit future opportunity to hunt this property.
- Walk-in only hunting from designated open roads with some designated parking. No off road travel.
- Lueck Ranch: Daily sign-in at roster box required to hunt this ranch. Hunting on foot or horseback only. No off road travel permitted. Know your target and please close gates.
- Permission for Lueck and part of Ruby Dell Ranch have been combined to require daily sign in at roster box. Lower unit of Ruby Dell Ranch require written permission slip from Jay Peterson at shop.


- Braach Ranch- Walk in hunting from designated road or parking area. Please call 24 hours prior to hunt at (406) 842-5521 between 6-9pm. Registration at sign in box is permission to hunt this ranch. Retrieval by motorized vehicle may be permitted with landowner permission. No Camping
- Lueck Ranch- Reservations required day before hunt. Please call between 6-9pm at (406) 842-5520. Sign-in at roster box required to hunt this ranch. Walk in hunting only. Retrieval by motorized vehicle may be permitted with landowner permission.
- Please be aware that there are homes adjacent to this BMA. Please observe safety zone.
