Township/Range: T13S-R9W & T14S-R9W

Dates BMA is open: Legal Fall Hunting Seasons for Antlerless Elk. Refer to current hunting regulations for specific season information.

Maps to have before you go: This BMA Map, available free at Butte, Bozeman & Helena Area FWP offices, **AND** the Beaverhead/Deerlodge National Forest Travel Plan 2008 (South), available for purchase through any Forest Service or Bozeman & Helena Area FWP offices.

Road Use: Vehicle travel permitted only on designated roads. Please refer to the Beaverhead/Deerlodge National Forest Travel Plan 2008 (South) for road use information on all roads outside of block management area boundaries.

How to get there: BMA access points are located West of Lima. See map for multiple access point locations.

Ranch Rules:

- Landowner permission slips required to hunt this area.

- Permission for parking areas C & D can be obtained by calling (800) 294-3940 between 7am-6pm on the specified Thursday call-in date. Permission will be granted on a first come, first served basis to 10 hunters. Calls before 7:00am will be invalid. Slips for these parking areas will only be available by mail. Hunters must have a slip in hand for access to this BMA. Hunters should be prepared to provide 1st and 2nd choice of hunt dates, hunter names, ALS numbers, phone number, mailing address. Permission slips are only valid for dates and names indicated.



- Park your vehicle and walk from designated parking areas. Some sites are easier than others. PTHV holders may be granted special access.
- This project is for antlerless elk only. Hunter numbers will be limited based on demand.
