Township/Range: T12N-R5W, T12N-R6W & T12N-R7W

Huntible Game: White-tailed Deer, Mule Deer, Elk, Black Bear & Upland Birds

Dates BMA is open: Legal Fall Hunting Seasons for White-tailed Deer, Mule Deer, Elk, Black Bear & Upland Birds. Refer to current hunting regulations for specific season information.

Maps to have before you go: This BMA Map, available free at Butte, Bozeman & Helena Area FWP offices, **AND** the Helena National Forest Travel Plan, available for purchase through any Forest Service or Bozeman & Helena Area FWP offices.

Road Use: Vehicle travel permitted only on designated roads. Please refer to the Helena National Forest Travel Plan for road use information on all roads outside of block management area boundaries.

How to get there: Weingartner BMA: Take Hwy 279, 15 miles north of I-15. Turn Left at Canyon Creek Store onto Little Prickly Pear Rd for 1/4 mile. Turn left onto Long Gulch Rd for 2 miles to sign-in box. Vincent BMA: Take Prickly Pear Rd to Lost Horse Creek Rd to Sign in at Deadman Rd or Anderson Rd


Ranch Rules:

- Walk-in hunting from designated roads. No off road vehicle travel.
- Weingartner Ranch - Every hunter must register at sign-in box each day before they hunt. Hunter signature is permission to hunt this area. Sign-In Boxes - Located 1/2 mile south of corrals. No Horseback Hunting Permitted. Any questions please call 406-368-2286 or 406-449-7425
 - Successful hunters may retrieve game with vehicle. Hunters successful in harvesting game may retrieve with vehicle but must write their intent to retrieve at sign in box prior to retrieval. Please follow this rule and report abuse of this retrieval rule if you see others driving without downed game.
- Vincent Ranch- Every hunter must register at sign-in box each day before they hunt. Hunter signature is permission to hunt this area. Walk in hunting from designated roads. No off road travel allowed. Livestock present on portions of this BMA. Use caution.
