Township/Range: T8N-R3W, T8N-R4W, T6N-R4W & T7N-R4W

Huntible Game: White-tailed Deer, Mule Deer, Elk, Black Bear & Upland Birds-No Antelope hunting permitted on SkyTop BMA

Dates BMA is open: Legal Fall Hunting Seasons for White-tailed Deer, Mule Deer, Elk, Black Bear & Upland Birds-No Antelope hunting permitted on SkyTop BMA. Refer to current hunting regulations for specific season information.

Maps to have before you go: This BMA Map, available free at Butte, Bozeman & Helena Area FWP offices, **AND** the Helena National Forest Travel Plan or Beaverhead/Deerlodge National Forest Travel Plan 2008 (North), available for purchase through any Forest Service or Bozeman & Helena Area FWP offices.

Road Use: Vehicle travel permitted only on designated roads. Please refer to the Helena National Forest Travel Plan or Beaverhead/Deerlodge National Forest Travel Plan 2008 (North) for road use information on all roads outside of block management area boundaries.

How to get there: Quartz Cr BMA- From Clancy, take Clancy Cr. Road 8 miles to the Quartz Creek Road. Proceed to BMA access point. Skytop BMA - Jefferson City parcel - Take Spring Street and Depot Road west out of Jefferson City 0.6 miles to corrals. Park at corrals. Boulder parcel - Take Boulder Frontage Road 1.5 miles. Turn left and go 1.25 miles to ranch headquarters. Amazon Parcel - Take Boulder Frontage Road 2.5 miles north. Turn west under interstate and travel 1/2 mile to sign-in box. Spring Gulch parcel - Take High Ore Road off I-15 to Comet Mile. Go 1/2 mile NE to sign-in box.


Ranch Rules:

- Walk-in or horseback hunting from designated roads or parking area. No off road motor vehicle travel.
- Every hunter must register at sign-in box each day before they hunt. Hunter signature is permission to hunt this area.
- Notice: There are other private in-holdings within the boundaries of this BMA. Hunting is not allowed on these areas. See map.
- Some ranch property is in a weapon restricted area or has no shooting zones. Please see map for details.
- Skytop Ranch - Written permission is required from ranch headquarters to archery hunt in the bottom land. See Map. Phone (406) 225-9620. Number of hunters will be limited in this area to 1 party per day. Proof of bow and arrow stamp required for permission to this unit.
- Game retrieval with landowner permission with vehicles permitted in afternoon.
- Hunters- Please be aware of landownership changes. Skytop Ranch has many private inholdings where houses and livestock may be present. Be aware of your target and take only safe shots.
- Disabled hunters may be able to drive beyond locked gates on SkyTop BMA on Tuesdays & Wednesdays. A separate permission slip will be required from landowner for disabled access. Not allowed in areas located within hunting district 335.
- Observe new safety zones/no shooting zones on Upper Valley and Amazon areas. Hunters may access through these areas but may not discharge a firearm until in the huntible portion of the BMA.
