**Township/Range:** T4N-R1W, T4N-R1E, T4N-R2E, T5N-R1W, T5N-R2W, T5N-R1E, T6N-R1W, T6N-R2W, T7N-R1W & T7N-R1E

**Huntible Game:** White-tailed Deer, Mule Deer, Elk, Antelope, Black Bear, Waterfowl & Upland Birds

**Dates BMA is open:** Legal Fall Hunting Seasons for White-tailed Deer, Mule Deer, Elk, Antelope, Black Bear, Waterfowl & Upland Birds. Refer to current hunting regulations for specific season information.

**Maps to have before you go:** This BMA Map, available free at Butte, Bozeman & Helena Area FWP offices, **AND** the BLM 100K Townsend, available for purchase through any Forest Service or Bozeman & Helena Area FWP offices.

**Road Use:** Vehicle travel permitted only on designated roads. Please refer to the BLM 100K Townsend for road use information on all roads outside of block management area boundaries.

**How to get there:** Williams Ranch is composed of multiple landowner units located West of Toston. These units can be accessed from Hwy 287 by Hwy 437, Lone Mountain Rd. & Hwy 285. See map for roster box locations.


### **Ranch Rules:**

- Walk-in hunting from designated roads. No off road vehicle travel.
- Every hunter must register at sign-in box each day before they hunt. Hunter signature is permission to hunt this area. Sign-in box locations are depicted on map.
- Some areas are restricted to Bird and Archery hunting only.
- ~~AAA~~No campfires. No camping.
- Please leave gates as you found them.
- Tom Williams Unit requires written permission from ranch house on site between 8am-8pm. Archery and Bird Hunting permitted in this area. Signing in at the box at Tom Williams house serves as written permission for this unit.


