**Hunting Districts:** D/E 380, Ant 380 & BMU 301

**Township/Range:** T7N-R1W, T9N-R1E, T9N-R1W, T8N-R1E & T8N-R1W

**Huntable Game:** White-tailed Deer, Mule Deer, Elk, Antelope, Black Bear & Upland Birds

**Dates BMA is open:** Legal Fall Hunting Seasons for White-tailed Deer, Mule Deer, Elk, Antelope, Black Bear & Upland Birds. Refer to current hunting regulations for specific season information.

**Maps to have before you go:** This BMA Map, available free at Butte, Bozeman & Helena Area FWP offices, **AND** the Helena National Forest Travel Plan, available for purchase through any Forest Service or Bozeman & Helena Area FWP offices.

**Road Use:** Vehicle travel permitted only on designated roads. Please refer to the Helena National Forest Travel Plan for road use information on all roads outside of block management area boundaries.

**How to get there:** Hahn Ranch - Located about 7 miles North of Townsend. From Hwy 12, turn west onto Kimber Gulch Road. Follow road to sign-in box at parking area. Winston Ranch - Ranch Headquarters are located in the town of Winston behind the Winston store.


## **Ranch Rules:**

- Winston Ranch - Walk-In hunting with written permission from ranch headquarters in Winston.
- Hahn Ranch - Walk-in hunting from Kimber Gulch road. No off road motor vehicle travel. Hunters may contact landowner for game retrieval.
- Every hunter must also register at sign-in box each day before they hunt. Signature is part of permission requirement to hunt this area.
- No motorized vehicles off designated roads.
- Some pastures may be closed to hunting if livestock is present.
- Please observe No Shooting Zones. No Shooting around buildings or livestock.
