

# Dragging Y Cattle Company Block Management Area #71

**Hunting Districts:** D/E 328 & 329; Ant 300 & 318; Moose 300 & 301, BMU 316

**Township/Range:** T8S-R13W, T9S-R14W, T9S-R13W, T9S-R12W, T9S-R11W, T10S-R14W, T11S-R14W, T11S-R13W, T11S-R11W & T12S-R14W

**Huntible Game:** White-Tailed Deer, Mule Deer, Elk, Antelope, Moose, Black Bear & Upland Birds

**Dates Conservation Easement is open:** Legal Fall Hunting Seasons for White-Tailed Deer, Mule Deer, Elk, Antelope, Moose, Black Bear & Upland Birds. Refer to current hunting regulations for specific season information.

**Maps to have before you go:** This Map, **AND** the Beaverhead-Deerlodge National Forest Travel Map (SOUTH), available for purchase through any Forest Service or Bozeman & Helena Area FWP offices.

**Road Use:** Vehicle travel permitted only on designated roads. Please refer to the Beaverhead-Deerlodge National Forest Travel Map (SOUTH) or road use information on all roads outside of Conservation Easement boundaries.


**How to get there:** Ranch headquarters are located 6.2 miles west of Clark Canyon Dam on Hwy 324.

## **Ranch Rules:**

- Written permission is required and can only be obtained at self serve roster boxes located at the Dragging Y Ranch Headquarters or L Diamond (see map).
- Place your permission slip on the dash of your vehicle.
- Walk-in only hunting from designated ranch or public roads. All vehicles and ATV's must stay on open roads.
- For safety reasons, hay meadows, pastures with livestock, and areas around ranch buildings are closed to all hunting.
- No Camping allowed on Dragging Y Cattle Company
- Remember, hunting on the Dragging Y Cattle Company is a privilege made possible by the voluntary cooperation of the landowner. Please do your part to take care of this land as if it were your own.

**HUNTING PRIOR TO OBTAINING LANDOWNER PERMISSION IS A VIOLATION OF  
MCA 87-3-304**

Every hunter must have permission. This includes possession of a written permission slip or signing in at a roster box **before** hunting.


