Hunting Districts: D/E 370 & 380, Ant 370 & 371

Township/Range: T5N-R3W & T5N-R4W

Huntible Game: White-tailed Deer, Mule Deer, Elk Antelope, Black Bear, Waterfowl & Upland Birds

Dates BMA is open: Legal Fall Hunting Seasons for White-tailed Deer, Mule Deer, Elk Antelope, Black Bear, Waterfowl & Upland Birds. Refer to current hunting regulations for specific season information.

Maps to have before you go: This BMA Map, available free at Butte, Bozeman & Helena Area FWP offices, **AND** the Beaverhead/Deerlodge National Forest Travel Plan 2008 (North), available for purchase through any Forest Service or Bozeman & Helena Area FWP offices.

Road Use: Vehicle travel permitted only on designated roads. Please refer to the Beaverhead/Deerlodge National Forest Travel Plan 2008 (North) for road use information on all roads outside of block management area boundaries.

How to get there: Compton Ranch - Travel 7 miles South of Boulder on Hwy 69. Turn East onto Elkhorn Rd. Go 1 1/2 miles to sign-in box located on the north side of the road. Dawson Ranch - Take Hwy 69 to mile marker 31. Box is located off west side of Hwy.

Ranch Rules:


- Compton - Walk-in hunting from public roads. Wednesdays & Thursdays- disabled hunters may drive on established roads. Every hunter must register at sign-in box each day before they hunt. Hunter signature is permission to hunt this area.
- Tom Dawson Ranch - Walk-in hunting from designated roads. No off road vehicle travel. Every hunter must register at sign-in box each day before they hunt. Hunter signature is permission to hunt this area.
- No off road motorized vehicle travel. Walk in from roads.
