**Township/Range:** T14S-R7W & T14S-R6W

**Huntible Game:** White-tailed Deer, Mule Deer, Elk, Antelope & Upland Birds

**Dates BMA is open:** Legal Fall Hunting Seasons for White-tailed Deer, Mule Deer, Elk, Antelope & Upland Birds. Refer to current hunting regulations for specific season information.

**Maps to have before you go:** This BMA Map, available free at Butte, Bozeman & Helena Area FWP offices, **AND** the Beaverhead/Deerlodge National Forest Travel Plan 2008 (South), available for purchase through any Forest Service or Bozeman & Helena Area FWP offices.

**Road Use:** Vehicle travel permitted only on designated roads. Please refer to the Beaverhead/Deerlodge National Forest Travel Plan 2008 (South) for road use information on all roads outside of block management area boundaries.

**How to get there:** Take Monida exit off I-15 and travel north approx. 1.5 miles. Turn left (west) on primitive road and follow to sign-in box at gate.


### **Ranch Rules:**

- Every hunter must register at sign-in box each day before they hunt. Hunter signature is permission to hunt this area. See map for sign-in box locations.
- Hunting from designated open roads or parking areas. Avoid tearing up roads during wet and muddy conditions.
- Please wash undercarriage of vehicles before using this BMA to reduce the spread or introduction of noxious weeds.
- No shooting in or around livestock.
- No camping, littering or open fires.
- Please leave gates as you found them - Open or Closed.
- Stay off roads when wet and impassible.


