Huntable Game: White-tailed Deer, Mule Deer, Antelope & Upland Birds

Dates BMA is open: Legal Fall Hunting Seasons for White-tailed Deer, Mule Deer, Antelope & Upland Birds. Refer to current hunting regulations for specific season information.

Maps to have before you go: This BMA Map, available free at Butte, Bozeman & Helena Area FWP offices, **AND** the Gallatin National Forest Travel Map (East Half 2006 or North 2012), available for purchase through any Forest Service or Bozeman & Helena Area FWP offices.

Road Use: Vehicle travel permitted only on designated roads. Please refer to the Gallatin National Forest Travel Map (East Half 2006 or North 2012) for road use information on all roads outside of block management area boundaries.

How to get there: The Sarrazin Ranch is located north of Livingston, Montana. From I-90, travel north on Hwy 89 for 11.5 miles. Take a right onto Shields River Road and drive approx. 2 miles to Tobin Creek Road. Take a left onto Tobin Creek Road and travel 1.5 miles until you reach 120 Tobin Creek Road.

Ranch Rules:


- Written permission is required to use this BMA. Permission can be obtained on site or by contacting Joe or Andy Sarrazin at (406) 686-4476 from 7:00-8:00a.m. and 7:00-9:00p.m.
- Home Unit (north portion) will be limited to 6 hunters per day. Sheep Mountain Unit (south portion) will be limited at landowner discretion.
- Walk-in hunting only. Parking will be designated at time of sign-up.
- No camping. No fires. No smoking allowed on this BMA.
