**DEER/ELK HD 400 & ANTELOPE HD 404 (REVISED 2016)**

**DATES BMA IS OPEN:** Archery & Rifle Seasons after 1 Sep / Upland Bird Seasons - through 1 Jan

**\*\*See applicable hunting regulations for specific dates for each Species & Season\*\***

**HUNTABLE GAME:** Open to all Legally Available Game Species

**WHERE & HOW TO GAIN ACCESS:** See each individual's info below ♦ Permission from one landowner **does not** cover another ♦ **All hunters must fill out all information on any hunter record required for access**

**ATTENTION:** *In an effort to protect grizzly bears and promote public safety, hunters are advised that this BMA includes grizzly bear habitat. You are encouraged to carry / use bear spray in case of an encounter. Additional information on proper behavior when hunting in bear country is available from FWP.*

## **1. KOLSTAD FARMS**

- No reservations taken ♦ All hunters must sign in at one of the sign-in boxes daily, before hunting.
- Driving permitted on existing, maintained or well-used roads & trails only.
- ATVs / OHVs may only be used for game retrieval if needed on the private property, but you may not hunt from them.
- **NO MOTORIZED TRAVEL ALLOWED ON DNRC (Blue) LANDS, WITH THE EXCEPTION OF THE TWO ROADS IDENTIFIED ON THE MAP.**

## **2. RUSS WICKS FARM**

- Reservations not taken ♦ **ALL** hunters must sign in daily, before hunting.

## **3. BUFFINGTON CORPORATION**

- Reservation not taken ♦ **ALL** hunters must sign in daily, before hunting.

## **4. BROADHURST RANCHES**

- Reservations not taken ♦ **ALL** hunters must sign in daily, before hunting.
- Motorized access restricted to main roads only.

## **5. PUGSLEY RANCHES**

- Reservations Required ♦ Call **791-8243, between 9AM – 9PM** ♦ At least 24 hrs in advance.
- *No reservations taken prior to 22 August.*
- Limit of 15 Hunters per Day.
- Hunters may not hunt more than 3 days at a time without leaving property and making new reservations.
- Hunters sign in at green sign-in box.
- **NO OVERNIGHT CAMPING ALLOWED ON PRIVATE PROPERTY.**

## **6. MEISSNER RANCHES (River Ranch)**

- All hunters must sign in at one of the sign-in boxes located throughout each area (A & B).

## **7. RIVERVIEW COLONY**

- Reservation not taken ♦ **ALL** hunters must sign in daily, before hunting.

## **8. SUNNYBROOK COLONY**

- Reservation not taken ♦ **ALL** hunters must sign in daily, before hunting.

## **BMA RULES & RESTRICTIONS:**

- **Obey all safety zones and landowners instructions.**
- No hunting around buildings or livestock.
- No designated parking areas
- Walk-in hunting only from roads & trails



### **STANDARD BLOCK MANAGEMENT PROGRAM RULES:**

- BMA restrictions do not apply to legally accessible, (via public roads and watercourses, and other legal means of access) public (State or Federal) lands.
- In accordance with BMP ARM rule 12.4.205 (k) - On BMA's that restrict hunter numbers or require reservations, a hunter may not reserve permission on more than one BMA for the same day(s). For aggregate (multi cooperators) BMA's, a hunter, or a party may still only make reservations with one (1) cooperator within that BMA per day.
- Individual or party hunters may not reserve permission to hunt for more than three days, per phone call, per BMA and may not call more than once per day. Individuals from the same hunting party may not each make reservations for consecutive "three-day blocks" in an attempt to book more than three days for that party.
- Hunter(s) who fail to call at least 24 hours in advance to cancel a reservation may be banned from that BMA, or, for aggregate BMA's, from the property owned by the cooperator with whom they made the reservations.
- A cooperator or their designated representative may deny access to an individual "for cause" IAW, ARM rule 12.4.205 (d). An example - intoxication, belligerence or violent behavior, violation of BMA rules, muddy/excessively filthy vehicle, etc. Cooperators may also ask FWP to ban an individual(s) for cause. This will be via a formal letter to the individual(s) from FWP and will specify the length of the ban, reasons, and complainant.
- Violations of any BMA rules and/or State hunting regulations will be prosecuted. Convictions may result in the loss of Block Management access privileges in addition to other penalties.



- *No reservations taken prior to 22 August.*
- Limit of 15 Hunters per Day.
- Hunters may not hunt more than 3 days at a time without leaving property and making new reservations.
- Hunters sign in at green sign-in box.
- **NO OVERNIGHT CAMPING ALLOWED ON PRIVATE PROPERTY.**

## **6. MEISSNER RANCHES (River Ranch)**

- All hunters must sign in at one of the sign-in boxes located throughout each area (A & B).

## **7. RIVERVIEW COLONY**

- Reservation not taken ♦ **ALL** hunters must sign in daily, before hunting.

## **8. SUNNYBROOK COLONY**

- Reservation not taken ♦ **ALL** hunters must sign in daily, before hunting.


