**DATES BMA IS OPEN:** Archery & Rifle Seasons after 1 Sep / Upland Bird Seasons - through 1 Jan  
**\*\*See applicable hunting regulations for specific dates for each Species & Season\*\***  
**Open Friday – Tuesday    Closed Wednesday & Thursday**

**HUNTABLE GAME:** Open to All Legally Available Game Species  
**Cooperator request more doe hunters.**

## **WHERE & HOW TO GAIN ACCESS:**

- Reservations required. ♦ Call 736-5502 from 8 am & 10 am only.
- *Requests for reservations may not be done until after 22 August.*
- Access to property allowed **after 6 am** only.
- If hunters have not checked in by noon, reservation will be cancelled automatically.
- All hunters in party must fill out all information on records used for granting access permission.
- Bird hunters are allowed to use up to 2 dogs per party.

**Parking Area 1 (P1): Up to 2 hunters per day.**

**Parking Area 2 (P2): Up to 2 hunters per day.**

## **BMA RULES & RESTRICTIONS PLUS LANDOWNER INSTRUCTION:**

- No discharge of firearms within 100 yards of livestock.
- No hunting within designated safety zones located within shelter belt.
- No trespassing within second safety zone around old homestead.
- Stay out of all buildings & structures on BMA.
- No tree stands ♦ No camping ♦ No littering ♦ No latrine pits ♦ No horses
- No open flames or ignition sources allowed outside of vehicles
- Motorized vehicles restricted to public roads, designated private roads, trails &/or parking areas.
- Walk in hunting only from these areas.
- **No ATVs/OHVs allowed on BMA.**

### **STANDARD BLOCK MANAGEMENT PROGRAM RULES:**


- BMA restrictions do not apply to legally accessible, (via public roads and watercourses, and other legal means of access) public (State or Federal) lands.
- In accordance with BMP ARM rule 12.4.205 (k) - On BMA's that restrict hunter numbers or require reservations, a hunter may not reserve permission on more than one BMA for the same day(s). For aggregate (multi cooperators) BMA's, a hunter, or a party may still only make reservations with one (1) cooperator within that BMA per day.
- Individual or party hunters may not reserve permission to hunt for more than three days, per phone call, per BMA and may not call more than once per day. Individuals from the same hunting party may not each make reservations for consecutive "three-day blocks" in an attempt to book more than three days for that party.
- Hunter(s) who fail to call at least 24 hours in advance to cancel a reservation may be banned from that BMA, or, for aggregate BMA's, from the property owned by the cooperator with whom they made the reservations.
- A cooperator or their designated representative may deny access to an individual "for cause" IAW, ARM rule 12.4.205 (d). An example - intoxication, belligerence or violent behavior, violation of BMA rules, muddy/excessively filthy vehicle, etc. Cooperators may also ask FWP to ban an individual(s) for cause. This will be via a formal letter to the individual(s) from FWP and will specify the length of the ban, reasons, and complainant.
- Violations of any BMA rules and/or State hunting regulations will be prosecuted. Convictions may result in the loss of Block Management access privileges in addition to other penalties.


