DATES BMA IS OPEN: Archery & Rifle Seasons after 1 Sep / Upland Bird Seasons - through 1 Jan
****See applicable hunting regulations for specific dates for each Species & Season****

HUNTABLE GAME: Open to All Legally Available Game Species

WHERE & HOW TO GAIN ACCESS:

- All hunters must sign in at sign-in box daily, before hunting.
- All hunters must fill out all information on any hunter record required for access.

BMA RULES & RESTRICTIONS:

- **OBEY SAFETY ZONES AND LANDOWNERS INSTRUCTIONS.**
- Park Along County Road or in designated parking areas ♦ Do Not Block Gates
- No Camping ♦ No Littering ♦ No Latrine Pits
- No Open Flames Or Ignition Sources Allowed Outside Of Vehicles
- **NO ATVs/OHVs ALLOWED ON BMA.**
- All Vehicles Restricted To Public Roads and Authorized, Designated Trails.
- No Motorized Vehicles Allowed Off of Designated Roads, Trails & Parking Areas.
- Walk In Hunting Only From These Areas.
- On Private Property in This BMA, Park Where Instructed.

HUNTERS: POLICE YOURSELVES & REPORT ANY APPARENT MISCONDUCT OR VIOLATIONS.


STANDARD BLOCK MANAGEMENT PROGRAM RULES:

- BMA restrictions do not apply to legally accessible, (via public roads and watercourses, and other legal means of access) public (State or Federal) lands.
- A cooperator or their designated representative may deny access to an individual “for cause” IAW, ARM rule 12.4.205 (d). An example - intoxication, belligerence or violent behavior, violation of BMA rules, muddy/excessively filthy vehicle, etc. Cooperators may also ask FWP to ban an individual(s) for cause. This will be via a formal letter to the individual(s) from FWP and will specify the length of the ban, reasons, and complainant.
- Violations of any BMA rules and/or State hunting regulations will be prosecuted. Convictions may result in the loss of Block Management access privileges in addition to other penalties.
