**DEER/ELK HD 403 & ANTELOPE HD 401 (REVISED 2016)**

**DATES BMA IS OPEN:** 1 Sep - through 1 Jan **\*\*See applicable hunting regulations for specific dates for each Species & Season\*\***

**ATTENTION:** *Bears may be present on the Ranch, to include grizzlies. Exercise appropriate caution & the carry of Bear Spray is encouraged.*

**HUNTABLE GAME:** Open to All Legally Available Game Species

**WHERE & HOW TO GAIN ACCESS:**

- Each hunter must sign in every day, before hunting.
- All hunters must fill out all information on any hunter record required for access.

**BMA RULES & RESTRICTIONS:**

- **OBEY SAFETY ZONES AND LANDOWNERS INSTRUCTIONS.**
- All Vehicles Restricted To Public Roads. ♦ Do Not Block Gates.
- **ANY ROAD NOT MARKED ON THIS MAP AS OPEN, OR POSTED BY FWP ON THE GROUND AS OPEN, IS CLOSED TO MOTORIZED USE.**
- Walk-In Hunting only.
- No Camping ♦ No Littering
- No Open Flames Or Ignition Sources Allowed Outside Of Vehicles.
- **NO ATVs / OHVs ALLOWED ON BMA.**

**HUNTERS: POLICE YOURSELVES & REPORT ANY APPARENT MISCONDUCT OR VIOLATIONS.**

**Be aware that private Landowners have the authority to drive anywhere within the BMA, but will always attempt to stay away from areas being hunted, unless need/situation demands otherwise.**

**STANDARD BLOCK MANAGEMENT PROGRAM RULES:**


- BMA restrictions do not apply to legally accessible, (via public roads and watercourses, and other legal means of access) public (State or Federal) lands.
- A cooperator or their designated representative may deny access to an individual “for cause” IAW, ARM rule 12.4.205 (d). An example - intoxication, belligerence or violent behavior, violation of BMA rules, muddy/excessively filthy vehicle, etc. Cooperators may also ask FWP to ban an individual(s) for cause. This will be via a formal letter to the individual(s) from FWP and will specify the length of the ban, reasons, and complainant.
- Violations of any BMA rules and/or State hunting regulations will be prosecuted. Convictions may result in the loss of Block Management access privileges in addition to other penalties.
