**DATES BMA IS OPEN:** Archery & Rifle Seasons after 1 Sep / Upland Bird Seasons - through 1 Jan  
**\*\*See applicable hunting regulations for specific dates for each Species & Season\*\***

**HUNTABLE GAME:** Open to All Legally Available Game Species

## **WHERE & HOW TO GAIN ACCESS:**

- No reservations required.
- EACH hunter must sign in, each daily before hunting.
- All hunters must fill out all information on any hunter record required for access

## **BMA RULES & RESTRICTIONS:**

- **OBEY SAFETY ZONES AND LANDOWNERS INSTRUCTIONS.**
- Park Along County Road or in parking designated spot ♦ Do Not Block Gates
- Walk In Hunting Only From These Areas
- Unless marked as open on this map or on the ground, all roads & trails are closed to motorized use.
- No Camping ♦ No Littering ♦ No Latrine Pits
- No Horses allowed on BMA.
- No Open Flames Or Ignition Sources Allowed Outside Of Vehicles.
- All Motorized Vehicles Are Restricted To Public Roads and Authorized, Designated Trails.
- **NO ATVs/OHVs ALLOWED ON BMA.**

**HUNTERS: POLICE YOURSELVES & REPORT ANY APPARENT MISCONDUCT OR VIOLATIONS.**

**Be aware that private Landowners & staff have the authority to drive anywhere within the BMA but will always attempt to stay away from areas being hunted, unless need/situation demands otherwise.**


## **STANDARD BLOCK MANAGEMENT PROGRAM RULES:**

- BMA restrictions do not apply to legally accessible, (via public roads and watercourses, and other legal means of access) public (State or Federal) lands.
- A cooperator or their designated representative may deny access to an individual “for cause” IAW, ARM rule 12.4.205 (d). An example - intoxication, belligerence or violent behavior, violation of BMA rules, muddy/excessively filthy vehicle, etc. Cooperators may also ask FWP to ban an individual(s) for cause. This will be via a formal letter to the individual(s) from FWP and will specify the length of the ban, reasons, and complainant.
- Violations of any BMA rules and/or State hunting regulations will be prosecuted. Convictions may result in the loss of Block Management access privileges in addition to other penalties.
