DEER/ELK HD 445 & ANTELOPE HD 450 (REVISED 2016)

Is not participating in elk shoulder season hunting. Elk hunting **only** allowed during the standard 6-week archery season (Sep 3 – Oct 16) and the 5-week general rifle season (Oct 22 – Nov 27).

DATES BMA IS OPEN: Archery & Rifle Seasons after 1 Sep . ****See applicable hunting regulations for specific dates for each Species & Season****

LANDOWNER IS PARTICIPATING IN EARLY YOUTH HUNT

HUNTABLE GAME: No Upland Bird Hunting. Otherwise, Open to All Legally Available Game Species Aside From Birds.

NO ACCESS TO ADJACENT SCHOOL TRUST LANDS IDENTIFIED ON THIS MAP, FROM BMA

WHERE & HOW TO GAIN ACCESS: Each hunter must sign in daily, for each area, before you begin your hunt. All hunters in a vehicle must place the stub portion of your sign-in coupon on the dash, face up.

BMA RULES, RESTRICTIONS: OBEY SAFETY ZONES AND LANDOWNERS INSTRUCTIONS.

- All Vehicles Restricted To Public Roads.
- Park Along County Road Where You Can Safely Pull Out Of Lane Of Traffic So That You Do Not Cause A Traffic Hazard.
- Walk In Hunting Only From Public Roads.
- Do Not Block Gates.
- No Camping, No Littering, No Latrine Pits And No Horses On BMA.
- No Open Flames Or Ignition Sources Allowed Outside Of Vehicles.
- **NO ATVs/OHVs ALLOWED ON BMA.**

HUNTERS POLICE YOURSELVES & REPORT ANY APPARENT MISCONDUCT OR VIOLATIONS.

HUNTERS BE AWARE THAT PRIVATE LANDOWNERS & STAFF HAVE THE AUTHORITY TO DRIVE ANYWHERE WITHIN BMA BUT WILL ALWAYS ATTEMPT TO STAY AWAY FROM AREAS BEING HUNTED UNLESS NEED/SITUATION DEMANDS OTHERWISE.


STANDARD BLOCK MANAGEMENT PROGRAM RULES:

- BMA restrictions do not apply to legally accessible, (via public roads and watercourses, and other legal means of access) public (State or Federal) lands.
- A cooperator or their designated representative may deny access to an individual “for cause” IAW, ARM rule 12.4.205 (d). An example - intoxication, belligerence or violent behavior, violation of BMA rules, muddy/excessively filthy vehicle, etc. Cooperators may also ask FWP to ban an individual(s) for cause. This will be via a formal letter to the individual(s) from FWP and will specify the length of the ban, reasons, and complainant.
- Violations of any BMA rules and/or State hunting regulations will be prosecuted. Convictions may result in the loss of Block Management access privileges in addition to other penalties.
