

STATUS OF ANGLING ACCESS AT MONTANA DAMS
(Revised 7/2010)

Heightened security to prevent potential terrorist activities may restrict fishing access at some dams this season. Some of the restrictions have been in place since September 11, 2002.

Thompson Falls Dam	PPL	Vista point & boat ramp closed seasonally. Gated off access to the dam itself.
Noxon Rapids Dam	AVISTA	Closed above the dam, marked by boater restraint cable. Closed for 1500 feet beneath the dam, marked by signs on shore.
Cabinet Gorge Dam	AVISTA	Closed above the dam, marked by boater restraint cable.
