

## Montana Bison Hunt Application, Licensing, and Harvest Data 2005-2009

**Notes:** In 2005, there was only one hunting district (encompassing the current HD385 and HD395). Under Senate Bill 91 (2005), 16 licenses are offered to the 8 Montana Native American Tribes (2 each). In 2005, 3 tribes accepted the licenses, 10 licenses went un-issued. In 2006 and 2007, the unaccepted tribal licenses were reissued to state hunters by drawing. State tribal hunter harvest is counted in the State Harvest total (not Tribal Treaty Harvest). ES=Either-Sex; CC=Cow/Calf. There is no mandatory reporting of bison harvest. These data are based on anecdotal reports from bison hunters, FWP staff, and Buffalo Field Campaign.
