FOR ALL LANDOWNER PREFERENCE: Landowner preference is applied only to the first choice hunting district. Only one person may be delegated landowner preference for each sole proprietorship, partnership or corporation. You **may NOT** apply for landowner preference for Deer, Elk or Antelope if you are applying as a party member. A corporation may delegate the landowner preference to a shareholder. If the license is valid for a portion of the hunting district only, the landowner must own the land within that portion.

FOR SPECIAL ANTELOPE, ANTELOPE B & DEER B LICENSES: To qualify for landowner preference, you must own or be contracting to purchase at least 160 acres of land in the hunting district for which you are making application. Your property must be primarily used for agriculture. Partnerships may delegate landowner preference to members of the immediate family (blood-related or marriage-related) or employed ranch manager (paid employee who has state, federal or FICA taxes withheld from their pay).

FOR ELK B: To qualify for landowner preference, you must own or be contracting to purchase at least 640 acres of contiguous land, used by elk in the hunting district for which you are making application. Unusual or infrequent sighting of one or a few elk is not sufficient qualification for landowner preference. Contiguous land is land that is not interrupted by adjacent private land. Partnerships may delegate landowner preference to members of the immediate family (blood-related or marriage-related) or employees who have state, federal or FICA taxes withheld from their pay.
