Montana Fish, Wildlife & Parks is requesting public comment on proposed 2013 Elk Quotas Outside Biennial Quota Ranges, 2013 Furbearer Quotas, Expanded Ground Set Trap Setbacks on Specific Public Routes, 2013 Bison Quotas and 2013 Elk Harvest Prescriptions in Specific Hunting Districts. Additional information is below including deadlines for public comment.

## **2013 Elk Quotas Outside Biennial Quota Ranges - Proposed**

Field surveys and analysis have identified one proposed quota change listed below that is outside the biennial quota range adopted in February 2012. All other changes are within the adopted biennial quota ranges, and are not presented here.

- 799-80: Increase antlerless B licenses from 200 to 400

## **2013 Furbearer Quotas - Proposed**

Proposed changes to 2013 annual furbearer harvest quotas are below, with other species quotas proposed as unchanged from 2012.

- Increase the bobcat quota in Trapping District 1 from 250 to 275
- Reduce the bobcat quota in Trapping District 4 from 300 to 200
- Increase the swift fox quota in a portion of Trapping District 6 from 20 to 30

Due to uncertainty surrounding the wolverines status under the Endangered Species Act, FWP is currently recommending a quota of 0. FWP may seek to adjust this at the October 2013 FWP Commission meeting. If a quota adjustment is proposed in October, public comment will be taken. A final rule would be considered at the November FWP Commission meeting.

- Decrease the statewide wolverine quota from 5 to 0.

## **Expanded Ground Set Trap Setbacks on Specific Public Routes – Proposed**

There is a proposed adoption of a 300 foot setback requirement for all ground sets on public land for identified and specific high recreational use routes listed below. The Commission expressed particular interest in public comments specifically addressing whether or not 300 feet is appropriate. NOTE these expanded setbacks are only for specific public land travel routes listed below.

- Require a 300 foot setback for ground sets on public land for specific high recreational use trails.

**2013 Bison Quotas - Proposed**

Montana's 2013 license quotas are proposed to remain the same at 44 either sex licenses (18 in HD 385 and 26 in HD 395); and 100 additional cow/calf licenses issued incrementally (54 in HD 385, 46 in HD 395) if conditions warrant. Of the 44 either sex licenses, 16 go to Montana Tribes as per state law. Additionally, four Tribes have asserted Treaty hunting rights and have stated intentions to hunt bison in the same areas outside Yellowstone National Park, but have not committed to any specific limit.

**2013 Elk Harvest Prescriptions in Specific Hunting Districts – Proposed (Appendix I)**

The FWP Commission adopted antlerless elk harvest prescriptions for the 2012 hunting season (Appendix I). Prescribed antlerless harvests were achieved in 6 hunting districts, portions of districts, or hunting district groups. Harvests were below prescription in the remaining 15 areas.

Adjusted prescriptions for the 2013 hunting season are now proposed for Commission adoption (Appendix I).
