Draft recommendations related to power lines, pipelines, wind energy

Catherine Wightman provided "straw-dog" recommendations from FWP on power lines, pipelines, and wind energy.

Council discussed recommendations and crafted draft recommendations for power lines, pipelines, and wind energy. Paul Callahan provided a draft structure, and refined power line recommendations, for documenting Montana's Council recommendations.

Completed draft document will be distributed prior to the next meeting.

Approved Motion: Council will send a letter to the APLIC working group requesting that the group completes their study and submits recommendations to this Council by October 1 so the work can inform Council's final recommendations

Council discussed a surface disturbance threshold to minimize cumulative impacts, both within and outside of core areas. This is a complicated discussion that requires additional clarification of definitions and spatial examples of how a disturbance threshold might be implemented. It was suggested that NRIS staff be asked to give a 'live' demonstration. Recommendations were not drafted.

Approved Motion: Council will spend one day at the July 16-17 meeting discussing a surface disturbance threshold. Wildfire and invasive species will be discussed on the other day.
