PECE policy review

Pat Deibert, USFWS (remote)

Pat Deibert gave a brief refresher to Council on PECE policy. It is for voluntary actions, not regulatory. Two main elements for a voluntary conservation strategy to be considered under PECE are the certainty of an action being implemented and the certainty of that action being effective.

Sandy Brooks and John Carlson presented on the range of alternatives found in draft Resource Management Plans relative to leasable, nonleasable, and fluid minerals. BLM reiterated that decisions made by Council will be considered before Resource Management Plans are finalized.

PUBLIC COMMENT

Gail Abercrombie requested that Rusty Shaw speak on behalf of Montana Petroleum Association.

Rusty Shaw encouraged Council to review WY Executive Order and Conservation Plan. He stressed that there are places that need to be protected and other areas that should be available for development. He questioned why Cedar Creek Anticline was designated a core area. He also requested that there not be a disturbance cap in general habitat; this would shut down industry. The intent should be to push development in to general, not restrict it there.

Bob Green provided additional comments regarding areas core areas that BLM designated as restoration areas instead of core areas because they already have or will have development pressure. He encourages Council to consider something similar.

Richard Brown asked DNRC if they could do an analysis on different conservation strategies in areas of potential development, not just current. DNRC indicated they didn't have a potential layer.

Matt Dillon re-iterated that mining impacts might be relatively small but disturbance caps would be significant. He also said that limitations on mining will have impacts on local economies.
