Bonus Point System

- ▶ **NEW** The fee to participate in the bonus point system is \$2.00 **per species** for residents.
 - ▶ You must pay the fee when applying to use or gain bonus points.
 - ▶ Applicants accumulate one bonus point for an unsuccessful year.
 - ▶ The bonus points become extra chances in future drawings.
 - ▶ The number of chances in a drawing equals the existing bonus points squared plus one.
 - ▶ Once successful, the applicant loses all points for that species.
 - ▶ Bonus points are accumulated independently for each species and only apply to “first-choice” districts.
 - ▶ An applicant may skip two consecutive years of participation without forfeiting accumulated points, but if an applicant misses the third year, all accumulated points for that species will be lost. Rejection of an application because of applicant error is equivalent to failure to apply.
 - ▶ Bonus points are non-transferable.
 - ▶ Applicants cannot apply just for a bonus point.
 - ▶ Current bonus point status is available online.
 - ▶ If short money for bonus points, no bonus points will be applied to any of the species choices.

BISON LICENSE \$10.00 nonrefundable application fee (Bonus points do not apply to Bison)

Application for Bison license drawing is a \$10.00 nonrefundable application fee. The drawing will be conducted in September once the FWP Commission sets the final Bison quotas and seasons. **If you are successful in the Bison drawing you will be required to purchase the Bison license for a fee of \$125.00**
